His Excellency, the Lieutenant-Governor, directs it to be publicly notified that the boundaries of the Sanitary District within which the powers of the "Sanitary Board" for Port Moresby may be exercised are duly set forth in the following Schedule, and the area therein defined shall be deemed to be and to constitute such Sanitary District accordingly:—

SCHEDULE.

Port Moresby.

All the land that is situated within the following boundaries:—Commencing at the point on the sea-shore of Ela Beach that would be met by a prolongation of the eastern boundary of the road called Lawes Street; thence by such boundary northwards to the most south-western point of the surveyed allotments of Granville East; thence by a line following the back or inland boundaries of the said allotments to the most north-eastern point; thence by a straight line following the most northern boundary of such allotments and prolonged to the sea-shore of Port Moresby harbour; thence on all other sides by the waters of the sea to the point of commencement.
