

PROCLAMATIONS MADE PURSUANT TO SECTION 36 OF THE POLICE OFFENCES ORDINANCE, 1912-1939, EXTENDING THE PROVISIONS OF PART III TO TOWNS.

[Proclamation dated 18th December, 1896, and published in *British N.G. Govt. Gaz.* of 2nd January, 1897.]

PROCLAMATION.

By Sir William MacGregor, Knight Commander of the Most
 [L.S.] Distinguished Order of Saint Michael and Saint
 WM. MACGREGOR. George, Lieutenant-Governor of the Possession of
 British New Guinea.

I, William MacGregor, Lieutenant-Governor of British New Guinea, do hereby proclaim and declare that the Town of Samarai shall come and is hereby brought under the operation of the Act Two Victoria

Number Two⁽¹⁾ (*Queensland adopted*) of the Act Eleven Victoria Number Forty-four⁽¹⁾ (*Queensland adopted*) and of the Act Nineteen Victoria Number Twenty-four⁽¹⁾ (*Queensland adopted*). For the purposes of the said Acts the boundaries of the said Town shall be the same as the boundaries of the Island of Samarai.

Given under my Hand and the Seal of the said Possession this eighteenth day of December, in the year of our Lord one thousand eight hundred and ninety-six and in the sixtieth year of Her Majesty's reign.

I, John Hubert Plunkett Murray, the Acting Administrator as aforesaid, by and with the advice of the Executive Council of the said Territory, do hereby proclaim and declare that the Township or Town of Buna shall come and be brought under the operation of "*The Police Act of 1838*," 2 Vic. No. 2⁽¹⁾ (*Queensland adopted*); of "*The Police Act of 1848*," 11 Vic. No. 44⁽¹⁾ (*Queensland adopted*); and of "*The Police Act of 1855*," 19 Vic. No. 24⁽¹⁾ (*Queensland adopted*).

For the purpose of the said Acts the boundaries of the said Township or Town shall be—

All that piece of land that is bounded by the waters of the sea and by the following lines, that is to say,—Beginning at a point on the sea-shore at the north-west corner of the lease of one hundred acres granted to the Synod of the Diocese of Brisbane, in trust for the Diocese of New Guinea; and thence running due south a distance of eighty chains; thence due north to the sea-shore; thence along the sea-shore to the point of commencement.

Given under my Hand and the Seal of the Territory, this eleventh day of September, in the year of Our Lord one thousand nine hundred and eight, and in the eighth year of His Majesty's reign.

I, John Hubert Plunkett Murray, Lieutenant-Governor aforesaid, by and with the advice of the Executive Council of the said Territory, do hereby proclaim and declare that the Township or Town of Daru shall come and be brought under the operation of "*The Police Act of 1838*," 2 Vic. No. 2⁽¹⁾ (*Queensland adopted*); of "*The Police Act of 1848*," 11 Vic. No. 44⁽¹⁾ (*Queensland adopted*); and of "*The Police Act of 1855*," 19 Vic. No. 24⁽¹⁾ (*Queensland adopted*).

For the purpose of the said Acts, the said Township or Town shall mean and include the whole of the island of Daru.

WHEREAS by an Ordinance (No. 44 of 1912) intituled the *Police Offences Ordinance, 1912*,⁽²⁾ it is amongst other things enacted that the Lieutenant-Governor may, by proclamation in the *Gazette*, extend the provisions of such Ordinance to any town specified in such proclamation: Now, therefore, I, the Administrator aforesaid, by and with the advice of the Executive Council and in pursuance of the powers vested in me by the said Ordinance, do hereby proclaim and declare that the provisions of the aforesaid Ordinance shall be and now are extended to the Town of Rouna, the definition of the boundaries of which are set forth in Order-in-Council of 24th August, 1912, and published in *Gazette* No. 12 of 1912 of 2nd October, 1912.⁽⁴⁾

(3) The definition of the boundaries published in *Gazette* No. 5 of 11.3.1913 was revoked by a Proclamation (made under the *Land Ordinance, 1911-1940*) dated 18.4.1915 and published in *Papua Govt. Gaz.* of 2.6.1915, which re-defined the boundaries. The latter Proclamation is printed below, title LAND. The boundaries as defined by the former Proclamation were as follows:—

"Commencing at a point bearing 300° distant ten chains from the South-Western corner of Portion G.M.L. 4 and bounded thence on part of the West by lines bearing 360° distant seventy chains, 50° distant one hundred and forty-six chains; thence on the East by lines bearing 140° distant eighty chains, 230° distant one hundred and thirty-five chains, 120° distant forty-seven chains, 210° distant eighty-two chains thirty-five links and thence bounded on the remainder of the West by lines bearing 300° distant ninety-one chains twenty-five links, 30° distant forty chains to the point of commencement."
