*Liquor (Licensing) Act 1963, as amended to date*

### PROHIBITION AND RESTRICTION OF SUPPLY OF LIQUOR

I, THOMAS KINGSTON CRITCHLEY, High Commissioner, by virtue of the powers conferred by Section 124 of the *Liquor (Licensing) Act 1963*, as amended to date, and all other powers me enabling, and having received the advice of the Executive Council, hereby—

- (a) prohibit the supply of liquor by each holder of a dealer's licence, storekeeper's licence and bottleshop licence, other than the supply of liquor by the holder of a storekeeper's licence in respect of a Duty Free Shop, for the period 7th September, 1975 to 17th September, 1975 (inclusive); and
- (b) prohibit the supply of liquor by each holder of a booth licence, dinner permit, supper permit or special permit for the period 13th September, 1975 to 17th September, 1975 (inclusive); and
- (c) prohibit the supply of liquor by each holder of an occasional licence, unless that holder has the prior written approval of the Chief Licensing Commissioner, for the period of 13th September, 1975 to 17th September, 1975 (inclusive); and
- (d) prohibit the supply of liquor by each holder of a publican's licence, tavern licence, canteen licence or club licence—
  - (i) on 15th September, 1975, except between the hours of—  
12 noon and 2 p.m. (inclusive) and 4 p.m. and 6 p.m. (inclusive); and
  - (ii) on 16th September, 1975, except between the hours of—  
12 noon and 2 p.m. (inclusive) and 5 p.m. and 7 p.m. (inclusive); and
  - (iii) on 17th September, 1975, except between the hours of—  
12 noon and 2 p.m. (inclusive) and 4 p.m. and 6 p.m. (inclusive); and
- (e) notwithstanding anything in this notice each holder of a publican's licence, limited hotel licence or residential club licence may sell, supply and dispose of liquor on licensed premises at any time to lodgers and their bona-fide guests within any guest lounge on the licensed premises and lodgers room by waiter service; and
- (f) notwithstanding anything in this notice each holder of a publican's licence, restaurant licence or limited hotel licence may sell, supply and dispose of liquor for consumption in the dining room of the licensed premises to persons having a meal between the hours of 12 noon and 2.30 p.m. (inclusive) and 6 p.m. and 10 p.m. (inclusive); and
- (g) prohibit the supply of liquor by each holder of a cabaret permit for the period 13th September, 1975 to 17th September, 1975 (inclusive).

**DECLARATION OF PUBLIC PLACES**

**I**, THOMAS KINGSTON CRITCHLEY, High Commissioner, by virtue of the powers conferred by Section 9 of the *Liquor (Miscellaneous Provisions) Act 1973*, as amended to date, and all other powers me enabling, hereby declare all public places in Papua New Guinea to be public places to which the provisions of Section 9 of that Act apply, other than premises which are the subject of a licence or permit under the *Liquor (Licensing) Act 1963*, as amended to date, for the period of 13th September, 1975 to 17th September, 1975 (inclusive).
