Medical Services Act 1965 (as amended)

NOTICE OF DISCIPLINARY ACTION

IN proceedings held before the Medical Board of Papua New Guinea on Thursday, 9th October, 1975 in the matter of charges under Section 60-(1)-(e)-(ii) of the *Medical Services Act 1965 (as amended)* against a registered Medical Practitioner; the Board having heard the evidence supporting the charges and having heard the testimony of the Medical Practitioner hereby finds—

- 1) that the Medical Practitioner is guilty of such professional misconduct which in the opinion of the Board, renders him unfit to be allowed to continue to practice in that he unlawfully laid hold of a patient on 2nd June 1975.

The Medical Board of Papua New Guinea therefore ordered that the name of the Medical Practitioner be removed from the Register of Medical Practitioners under Section 60-(1)-(f) of the *Medical Services Act*.

NOTICE OF DISCIPLINARY ACTION

IN proceedings held before the Medical Board of Papua New Guinea on Monday, 15th December, 1975 in the matter of charges under Section 60-(1)-(e)-(ii) of the *Medical Services Act 1965 (as amended)* against a Registered Medical Practitioner; and the Board, having heard the evidence supporting the charges and having heard the testimony of the Medical Practitioner and witnesses hereby finds—

- 1) that the Medical Practitioner is guilty of professional misconduct in that he—

(a) on 5th May, 1975 requested a Nurse who was on hospital duty, to accompany him to his office for purposes unrelated to employment.

The Medical Board of Papua New Guinea thereby ordered that the Medical Practitioner be reprimanded under Section 60-(1)-(i) of the *Medical Services Act 1965 (as amended)*.

IN proceedings held before the Medical Board of Papua New Guinea on Thursday, 11th December, 1975 in the matter of charges under Section 60-(1)-(e)-(ii) of the *Medical Services Act 1965 (as amended)* against a registered Medical Practitioner; the Board, having heard the evidence supporting the charges and having heard the testimony of the Medical Practitioner and witnesses thereby finds—

- 1) that the Medical Practitioner is guilty of professional misconduct in that she—

(a) failed to attend to a patient on the night of 18th September, 1975, when called upon to do so.

The Medical Board of Papua New Guinea therefore determined that under Section 60-(1)-(b) of the *Medical Services Act 1965 (as amended)* the Medical Practitioner was ordered to pay by way of a pecuniary penalty the sum of K100.00.
