DETERMINATION OF THE PAR VALUE OF THE KINA

I, John Guise, G.C.M.G., Governor-General, by virtue of the powers conferred by Section 48(1) of the *Central Banking Act 1973* and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, after consultation with the Bank of Papua New Guinea and in accordance with any international agreement to which Papua New Guinea is a party, hereby—

- (a) revoke the notice of determination of par value of the kina dated 28th November, 1976, and published in *National Gazette* No. G94 of 1st December, 1976; and
- (b) determine that the par value of the kina shall be equal to one dollar fifteen and fifty hundredths cents (\$1.1550) in the currency of Australia,

with effect on and from 6 p.m. on 13th December, 1976.

CONSTITUTION

AMENDMENT OF DETERMINATION OF RESPONSIBILITIES OF MINISTERS IN RELATION TO ADMINISTRATION OF LEGISLATION

I, Michael Thomas Somare, Prime Minister, by virtue of the powers conferred by Section 148(1) of the Constitution and all other powers me enabling, hereby amend the Determination of Responsibilities of Ministers in relation to Administration of Legislation dated 27th April, 1976 and published in *National Gazette* No. G39 of 13th May, 1976—

- (a) by omitting the words "the Schedule" and Substituting "a Schedule"; and
 (b) by omitting the word "SCHEDULE" and Substituting "SCHEDULE 1"; and
 (c) by inserting after SCHEDULE 1 the following Schedule:—

7. Unless otherwise determined by the Minister the Enterprise shall engage in no business activities in Papua New Guinea other than the construction of the first 342 houses to be built by the Enterprise for Bougainville Copper Limited.

8. The Enterprise will at all times conduct its operations in such a way as to minimise deleterious effects on the environment and will abide by any reasonable standards specified by the Minister responsible for environmental matters.

9. The Enterprise shall within one month from the date of registration seek registration in Papua New Guinea under the *Companies Act 1963* as amended, as a foreign company.

10. Any application by the Enterprise for approval of, or a determination by, the Minister required by or to be given in accordance with any of these terms and conditions shall be made in writing to NIDA.

11. The Enterprise will keep all its books of account and records in Papua New Guinea and in the English language.

12. The Enterprise shall not without the prior approval of the Minister carry on the activity for which it is registered in any location in Papua New Guinea other than Bougainville Province.

13. The Enterprise shall use Papua New Guinean supplies of roofing lumber unless prior to the first shipment the Enterprise produces reasonable documentary evidence to NIDA that the landed cost in Bougainville including duty of imported roofing lumber is less than K26 per 100 superfeet. Unless within seven days of receipt of such evidence by NIDA a notice of objection is communicated to Homexpo NIDA shall be deemed to have approved the shipment of lumber.
