DETERMINATION OF FUNCTIONS OF DEPARTMENTS

I, Tore Lokoloko, G.C.M.G., Governor-General, by virtue of the powers conferred by Section 23(1) of the *Public Service (Interim Arrangements) Act 1973* and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby amend the Determination of Functions of Departments dated 2nd February, 1976 and published in *National Gazette* No. G15 of 13th February, 1976 by—

(a) omitting Schedule 11A; and

(b) inserting after Schedule 1A the following Schedule:—

"SCHEDULE 1B

DEPARTMENT OF DECENTRALIZATION

1. Encourage and assist in the establishment of provincial governments.
2. In Provinces in which provincial government is established, provide administrative services to those provincial governments.
3. To the extent that the responsibility for carrying out such activities has not been assumed by provincial governments, and until it is so assumed—
 - (a) exercise in the Provinces such powers and functions as are from time to time specified by decision of the National Executive Council as provincial powers and functions and are transferred to it from other Departments; and
 - (b) administer Local Governments in Provinces at headquarters and field level and regulate the Local Government Service.
4. Exercise Police functions outside Police Districts or magisterial powers as necessary.
5. Protect rights and interests in land of automatic citizens and provide investigatory and advisory services in respect of all land matters affecting the interests of automatic citizens.
6. Social and Community Development and Social Welfare."

DECLARATION OF SPECIAL AREA

I, Julius Chan, Minister for Primary Industry, by virtue of the powers conferred by Section 15A(1) of the *Forestry Act (Amalgamated)* 1973 and all other powers me enabling, hereby declare the Central New Ireland timber rights purchase area, details of which are specified in the Schedule, to be a special area for the purposes of the Act.

*Local Government Act 1963***DIRECTION CONCERNING DISPOSAL OF ASSETS CONSEQUENT ON AN ORDER FOR THE WINDING-UP OF THE BUKA, TEOP-TINPUTZ, WAKUNAI, BANA, SIWAI, KIETA, BUIN AND EIVO LOCAL GOVERNMENT COUNCILS AND SOUTH BOUGAINVILLE ROAD SPECIAL PURPOSES AUTHORITY**

*Civil Aviation Regulation 1975***DETERMINATION OF THE CONDITIONS OF THE USE OF AN AERODROME**

I, Joseph James Tauvasa, Controller of Civil Aviation of the Department of Transport and Civil Aviation, in pursuance of the powers conferred on me by Section 80 of the *Civil Aviation Regulation 1975*, hereby determine the following conditions of the use of the Port Moresby, Wewak, Kieta, Daru and Vanimo aerodromes established and provided by the Minister for Transport in pursuance of that section and under my control and management.

1. Every person proposing to board an aircraft departing from the aerodromes shall submit himself and his carry-on baggage to be searched by an employee of the operator of the aircraft on which he proposes to travel, a person authorised for that purpose by the operator, an officer of the Department of Transport and Civil Aviation (Division of Civil Aviation), an officer of the Civil Aviation Agency, or a member of the police force of Papua New Guinea, in any case in which an employee of the operator or an officer of the Department of Transport and Civil Aviation (Division of Civil Aviation), or an officer of the Civil Aviation Agency requires in the interests of the safety of air navigation that all or any of the passengers proposing to travel on a particular aircraft departing from the aerodromes or their carry-on baggage should be searched, provided that a female shall not be searched except by a female.
2. Every operator operating any aircraft at the aerodromes shall comply with a written aviation security program approved by the Controller. This program shall be prepared by the operator and shall set out the procedures and equipment that will be used to:
 - (i) prevent or deter the unauthorized carriage on an aircraft of any firearm, weapon, ammunition, explosive or incendiary device, in baggage (including unaccompanied baggage), cargo or mail or on the person of a passenger;
 - (ii) prevent or deter unauthorised access to aircraft owned or operated by the operator;
 - (iii) ensure that baggage (including unaccompanied baggage), cargo and mail is accepted only in accordance with the aviation security program;
 - (iv) prevent baggage (including unaccompanied baggage), cargo and mail being loaded aboard a flight except in accordance with the requirements of the aviation security program;
 - (v) ensure that adequate inspections of aircraft are conducted in the event of bomb or other threats being received.
3. Every operator shall inform the Controller of the person who is responsible for the development and application of the aviation security program, shall maintain an up-to-date copy of the aviation program, shall ensure that its contents are available and made known to the appropriate members of his staff, and shall make a copy of the program available on request to an authorised officer of the Department of Transport and Civil Aviation (Division of Civil Aviation), an officer of the Civil Aviation Agency, or a member of the police force of Papua New Guinea.
