DECLARATION OF PUBLIC PLACES

*Liquor (Licensing) Act 1963***RESTRICTION ON SALE AND SUPPLY OF LIQUOR**

I, Nahau Kambuou Rooney, Minister for Corrective Institutions and Liquor Licensing, by virtue of the powers conferred by Section 31 of the *Liquor (Licensing) Act 1963* and all other powers me enabling, subject to the Notice of Restriction of Sale and Supply of Liquor dated 30th March, 1977 and published in *National Gazette* No. G32 of 7th April, 1977, hereby restrict or limit the sale or supply of liquor under a publican's licence, bottleshop licence and storekeeper's licence throughout the Bougainville Province during the week commencing on and from Friday, 2nd September, 1977 and ending on Thursday, 8th September, 1977 (inclusive) to Saturday, 3rd September, 1977 to Thursday, 8th September (inclusive).
