FOURTH NATIONAL INVESTMENT PRIORITIES SCHEDULE

CHAPTER 1

INTRODUCTION TO THE NATIONAL INVESTMENT PRIORITIES SCHEDULE

The National Investment Priorities Schedule is published by the Governor-General acting on the advice of the National Executive Council and is required to be revised at least once in every period of 12 months.

Fourth National Investment Priorities Schedule—*continued*

Chapter 1—*continued*

The purpose of publishing the National Investment Priorities Schedule and the form that it should take are best described by quoting the relevant sections of the Act.

41. PURPOSE OF THE SCHEDULE

- (1) The purpose of the Priorities Schedule is to inform potential investors and persons and bodies responsible for planning, promoting or encouraging investment of the priorities attached by the Government to investment in particular areas and fields.
- (2) It is a function of NIDA to ensure that any relevant provisions of the Priorities Schedule are drawn to the attention of investors and potential investors.

42. FORM OF THE SCHEDULE

The Priorities Schedule shall set out—

- (a) lists of activities in which business—
 - (i) by registered foreign enterprises is allowed; or
 - (ii) is reserved for local enterprises; and
- (b) guidelines for potential foreign investors, and the minimum terms and conditions that are required or expected to be complied with; and
- (c) such other matters as the Head of State, acting on advice directs.”

CHAPTER 2

PRIORITY ACTIVITIES

Foreign investment in these activities is considered to be an essential part of Papua New Guinea's development programmes over the coming years.

The following list identifies priority projects where the Government of Papua New Guinea has decided in principle to offer access to a particular resource for development by foreign investment.

More detailed information on individual project profiles is obtainable from NIDA on request, and more detailed information on the terms on which development of each project is sought is obtainable through NIDA.

MINERALS AND PETROLEUM

The Government considers the development of mining and petroleum projects to be of the highest priority and welcomes foreign investors interested in carrying out exploration in areas where prospecting concessions are not held by other enterprises.

Areas with considerable potential are currently available for exploration.

Prospecting concessions are granted by the Minister for Minerals and Energy who is advised by the Mining Advisory Board and the Petroleum Advisory Board. When it is considered desirable to do so, areas available for prospecting concessions are advertised internally. Current information on prospecting concessions is obtainable from and applications for concessions are made to the Secretary, Department of Minerals and Energy.

All geological information known on prospect areas, other than the findings of current concession holders, is publicly available and may be obtained from the Chief Government Geologist, Geological Survey Division.

To assist the exploration for and development of mineral and petroleum resources, exemptions from the registration requirements (Part VI) of the National Investment and Development Act have been granted to:

1. Foreign enterprises exclusively engaged in drilling, seismic survey and other forms of exploration for minerals or hydrocarbons.
2. Foreign enterprises exclusively engaged in providing services of any kind for the enterprises specified in paragraph 1.

Guidelines for potential investors are outlined in Chapter 5.

AGRICULTURE AND INTEGRATED AGRICULTURAL INDUSTRIES

Growing and Processing of Tea

Tea is an export-oriented crop with 5 000 tonnes domestic production being approximately ten times domestic demand.

As a broad guide a planted tea area of 700 hectares and tea factory of 1 400 tonnes made tea per annum capacity could be considered an acceptable package. The Government may also expect the investor to enter into a formal agreement, with the Government itself or some other organisation, for smallholder green tea leaf to be processed by the state factory. The designed capacity of the factory should therefore allow for this.

Likely location is the Southern Highlands Province.

Growing of Legume and Grain Crops

Crops such as soya, maize, sorghum and rice.

Total rice imports in 1975/76 were 55 000 tonnes, valued at K13.2 million f.o.b. Domestic market growth is estimated at 4% per annum.

Growing and Processing of Sugar Cane

Total sugar imports in 1975/76 were 20 000 tonnes. Domestic market growth is estimated at 3% per annum. A sugar industry with an output of 30 000 tonnes per annum is considered to be the basic investment package.

There is suitable land for these crops in the Markham Valley (23 000 hectares), at Kemp Welch (2 500 hectares) and Bereina (5 000 hectares).

Guidelines for new foreign investment in these activities are outlined in Chapter 5.

FORESTRY AND INTEGRATED FOREST INDUSTRIES

Integrated Timber Developments in the following areas:

1. Sagarai-Gadaisu Timber Rights Purchase Area

Total area of 160 000 hectares situated in the Milne Bay and Central Provinces; 58 000 hectares of productive tropical forest; 2.5 million cubic metres of logs suitable for sawn timber or veneer; 2.5 million cubic metres of pulpwood.

2. Vanimo Timber Rights Purchase Area

Total area 287 000 hectares near Vanimo, West Sepik Province; 234 000 hectares of productive tropical forest; 14 million cubic metres of logs suitable for sawn timber or veneer; 21 million cubic metres of pulpwood.

3. Kapuluk Timber Rights Purchase Area

Total area 181 000 hectares on the north coast of New Britain, West New Britain Province; 181 000 hectares of productive tropical forest; 5.8 million cubic metres of logs suitable for sawn timber or veneer; 7.3 million cubic metres (preliminary estimate) of pulpwood.

Detailed species, composition and other information on these purchase areas is available from the Office of Forests.

A timber project should be designed properly to utilise the forest resources of the purchase areas so as to most benefit the people of the area, the Province and the nation; and provide fair returns to skills and capital provided. An acceptable project will include one or more of the following:

- development of alternative land use schemes such as agriculture or reforestation;
- providing infrastructure for the development of the region;
- production of sawn timber;
- veneer production;
- woodchipping in association with reforestation; and
- other further processing of timber, for example:
 - kiln drying of sawn timber;
 - reconstituted wood products;
 - plywood;
 - furniture and furniture components for export; and
 - wooden manufactures.

Guidelines for new foreign investment in these activities are outlined in Chapter 5.

FISHING AND INTEGRATED FISHING INDUSTRIES

Development of the tuna fishing industry.

In the long term a sustainable catch of 100 000 tonnes per annum is considered to be feasible.

The development of the industry is to include the establishment of:

- fishing fleets of tuna long liners and purse seiners;
- shore based storage and processing terminals. Processing should include gilling and gutting, heading and tailing, loining and/or canning, and the manufacture of fishmeal; and
- shore based fleet servicing facilities.

The shore facilities to service the tuna industry are to be resource oriented with the Bismarck Archipelago providing the most highly developed resource area.

Development of the Prawn and Lobster Fishing Industry

The development of the industry is to include:

- development of locally owned processing facilities on a contract management basis;
- collection of catches from Papua New Guinean fishermen; and
- contract marketing services for prawns, lobster, crayfish, yabbies, crabs, reef fish and white fish.

Details of this industry are given in the prospectus *The Gulf of Papua—Marine and Inland Fisheries*, published by the Fisheries Division, Department of Primary Industry and NIDA.

Offshore Fishing

This should include the development of onshore processing of suitable products for the domestic market.

Imports of canned mackerel, which make up about 90% of all imports of canned fish, were about 21 000 tonnes in 1975/76 valued at about K7½ million f.o.b.

In addition to the above identified priorities the Government would welcome exploration for unproven offshore marine resources.

Guidelines for new foreign investment in these activities are outlined in Chapter 5.

CHAPTER 3

OPEN ACTIVITIES

All business activities other than those on the Reserved List and those projects on the Priority List are Open Activities in which new foreign investment is allowed.

Investment proposals will be considered by the Government on individual merit, and approval decisions will be based on the criteria included in the Guidelines and Minimum Terms and Conditions for New Foreign Investment which are to be found in Chapter 5.

These principles apply to all foreign investment in Open Activities but in order to draw investors' attention to those areas in which foreign investment is more likely to be encouraged and to assist investors with their planning generally the following information is published:

In addition to projects already listed as Priority Activities the Government will search for and investigate projects suitable for development by private investment. When projects are identified as being beneficial to Papua New Guinea and appropriate for foreign investment, these projects will be promoted through NIDA. Interested investors are invited to obtain information on such potential projects from NIDA.

There are a number of business activities and types of business in which development by means of foreign investment is expected to rate highly in terms of the criteria in the Guidelines and in which the Government welcomes foreign investment proposals with interest. These are listed below.

In other Open Activities not listed below there will be considerable regional variation in the extent to which foreign investment proposals are in accordance with or conflict with the Guidelines. Investors will be informed by NIDA if their plans involve sensitive issues or if there are known conflicts, in particular with Guidelines 8 and 10. In addition, if there is a precedent of new foreign investment having been determined not to be acceptable in a particular type of business activity in a particular area, the investor will be informed by NIDA.

OPEN ACTIVITIES IN WHICH FOREIGN INVESTMENT PROPOSALS ARE WELCOMED WITH INTEREST

Agriculture and Livestock

Growing of food crops.

Growing of fruit trees.

(Provided that the food and fruit grown are to be used for these purposes:
to supply fresh food to defined food deficit areas;
to supply food processing industries.)

Oil Palm Growing (Selective nucleus estate development only).

Rubber Growing (Selective nucleus estate development only).

Kumusi Timber Rights Purchase Area

Total area of 70 000 hectares situated north-west of Popondetta, Northern Province; 34 700 hectares of productive tropical forest; 2.3 million cubic metres of logs suitable for sawn timber or veneer; 2.0 million cubic metres of pulpwood.

Kapiura Timber Rights Purchase Area

Total area 85 000 hectares on north coast of New Britain, West New Britain Province; 83 000 hectares of productive tropical forest; 3.9 million cubic metres of logs suitable for sawn timber or veneer; 2.6 million cubic metres of pulpwood.

Umboi Island Timber Rights Purchase Area

Total area 95 000 hectares on Umboi Island, in Vitiay Strait, Morobe Province; 55 600 hectares of productive tropical forest; 4.3 million cubic metres of logs suitable for sawn timber or veneer; 4.0 million cubic metres of pulpwood.

Manus Island (subject to purchase of timber rights by the Government)

Total area 47 000 hectares on Manus Island; 47 000 hectares of productive tropical forest; 3.6 million cubic metres of logs suitable for sawn timber or veneer; 3.5 million cubic metres of pulpwood.

Jimi Timber Rights Purchase Area

Total area 127 000 hectares situated north of Mt Hagen in the Western Highlands and Enga Provinces; 87 000 hectares of productive tropical forest; 5.2 million cubic metres of logs suitable for sawn timber or veneer; 4.7 million cubic metres (preliminary estimate) of pulpwood.

Detailed species, composition and other information on these purchase areas is available from the Office of Forests.

Fishing

Pearl farming.

Prawn farming.

Eel farming.

Farming of edible oysters and mussels.

Inshore fishing.

Development of a mangrove crab industry.

Development of a precious and semi-precious deepwater coral industry.

(Except for pearl farming and development of a precious and semi-precious deepwater coral industry, the Government will require joint ventures between the foreign investor and traditional right-holders and/or the provision by the foreign investor under mutually acceptable agreements of facilities for collecting, processing and marketing of products supplied by Papua New Guinean producers.)

Manufacturing

Export oriented further processing of the output of the agricultural, fishing, forestry and minerals sectors.

Manufacture of inputs required by the agricultural, fishing, forestry, minerals and construction sectors.

Expansion and diversification of existing manufacturers into new export products or new import substitution markets.

Canning and preserving of fruits and vegetables.

Manufacture of prefabricated wooden buildings.

Manufacture of hand tools (especially for agriculture).

Manufacture of dry batteries.

Ship building and repairing.

Construction

Construction activities using specialised skills not available at competitive costs in Papua New Guinea.

Trading

Export of minor agricultural products (in the form of a joint venture with Papua New Guinean interests).

Tourism, Restaurants and Hotels

A National Tourism Plan is being prepared. The development, management and operation of hotels, motels, recreation facilities or other tourist attractions of a type and in a site conforming to the provisions of the National Tourism Plan will be promoted.

Development, management and operation of lower cost guest accommodation (in the form of a joint venture with Papua New Guinean interests).

Other Services

Technical and professional services.

CHAPTER 4

RESERVED ACTIVITIES

The following list specifies those business activities in which foreign investors will not, as a general rule, be allowed to establish new businesses or to take over existing businesses.

Minerals and Petroleum

Small scale alluvial gold mining.

Agriculture and Livestock

Coconut growing (other than the development of a new hybrid coconut industry).

Coffee growing.

Poultry farming, raising of broilers only.

Orchid growing.

Sericulture.

Wildlife

Gathering of uncultivated natural products, including uncultivated forest materials such as gums and resins, wild rubber, saps, barks, herbs, wild fruits, flowers and plants, mosses, leaves, needles, reeds and roots.

Hunting of crocodiles.

Small scale crocodile farming (under 5 000 head).

Hunting, collecting and farming of non-protected fauna, including insects, coral, shells, animal teeth, tusks, feathers and similar products, and living or dead fauna but excluding all fauna listed in the Priority Activities or specifically published in the Open Activities, large scale crocodile farming and inland fish farming.

Fishing

Inland fishing.

Manufacturing

Processing of copra (through to dry copra).

Processing of cocoa (through to dry bean), other than processing of own production by plantations.

Processing of coffee (through to green bean).

Processing of peanuts.

Silkscreen printing of piece goods.

Manufacture of handicrafts.

Commercial reproduction of traditional artifacts.

Trading

Trading and exporting copra.

Trading and exporting commodity coffee.

Trading and exporting commodity cocoa.

Wholesaling and retailing orchids (except by florist shops).

Wholesaling and retailing of uncultivated natural products, including uncultivated forest materials, such as gums and resins, wild rubber, saps, barks, herbs, wild fruits, flowers and plants, mosses, leaves, needles, reeds and roots.

Wholesaling and retailing and exporting of non-protected fauna, including insects, coral, shells, animal teeth, tusks, feathers and similar products, and living or dead fauna, but excluding all fauna listed in the Priority Activities or specifically published in the Open Activities and crocodile skins.

Wholesaling and retailing of handicrafts.

Rural trade stores.

Mobile trading establishments.

Retailing of automotive fuels (except when included with motor vehicles and motor cycle service and repair facilities).

Retailing of second-hand clothing.

Restaurants and Motels

Refreshment and eating places employing less than six people on a full-time basis (except where integrated with hotels and guest houses).

Taverns (except where integrated with hotels).

Transport

All land transport (except management services).

Other Services

Amusement parlours.

Hire of vending and amusement machines.

Footwear repairing (except where carried out jointly with shoe manufacturing, wholesaling, or retailing).

CHAPTER 5

GUIDELINES AND MINIMUM TERMS AND CONDITIONS FOR NEW FOREIGN INVESTMENT**GENERAL GUIDELINES**

1. In the appraisal and negotiation of investment proposals Government will give consideration to the following aspects:

The investor's past record both in Papua New Guinea and overseas.

Creation of additional employment and income earning opportunities.

Contribution to equalising income distribution.

Contribution to decentralisation.

Generation of additional government revenue.

Generation of net additional foreign exchange earnings.

Fourth National Investment Priorities Schedule—*continued*Chapter 4—*continued*

Transfer of technologies and skills suitable for Papua New Guinea.

Contribution to training of Papua New Guineans.

Contribution to economic growth.

Encouragement and assistance to Papua New Guineans in establishing related businesses.

Impact on the physical and social environment.

Contribution to consumer welfare.

2. As a general rule, no agreement between the Government of Papua New Guinea and a foreign enterprise will be incorporated in an Act of Parliament.
3. *Finance*: Loan and capital funding of new foreign investments should normally be made off-shore except that in periods of high domestic liquidity the Government may permit limited borrowings in the domestic capital markets. The ratio of loan to equity funds should not normally exceed 60:40, so as to ensure adequate asset cover for the investment.
4. *Contracts and Agreements*: Sales, management and similar contracts should not contain provisions of an unduly onerous or restrictive nature.
5. *Foreign Exchange*: It is Government policy to ensure the availability of foreign exchange to private investors to enable them to make all current payments overseas arising from the carrying on of business in Papua New Guinea. Current payments include payments as dividends, rents, interest due to overseas residents, travelling expenses, and personal payments as well as imports of goods and services. The Government has accepted an obligation under Article 8 of the International Monetary Fund to continue to permit such payments without limit.

Overseas loan repayments will be permitted without limit provided the receipt of the loan funds into Papua New Guinea had prior exchange control approval. For major projects, the Government is prepared to discuss arrangements to guarantee kina convertibility for the purpose of loan repayments. The Government will not agree to guarantee the commercial viability of any private sector investment by guaranteeing the credit repayments to financial institutions. Where the State is a substantial equity partner in an investment some limited form of credit guarantee may be considered.

6. *Price Competitiveness and Protection*: It is Government policy to encourage the establishment in Papua New Guinea of industries which are efficient by world standards, which can produce at or below import parity prices, and which do not depend on special financial or other concessions for their continued survival.

The Government will consider limited, short term protection for industries where such protection is required during the early years of production, and where a net benefit to the economy will result from the granting of such protection. The nature and duration of the protection for such industries will, in all cases, be agreed on before the establishment of the proposed industry. Before considering any requests for protection or other concessions, the Government will require such information as it considers necessary to enable it to make a proper assessment of the need for such concessions. The Government will not provide permanent substantial protection to clearly uncompetitive industries.

Forms of protection which might be granted include tariffs, subsidies and import restrictions. Where protection is granted to give an enterprise a guaranteed market share, the Government reserves the right to apply price controls.

The creation of special duties to counteract "dumping" of goods in Papua New Guinea is provided for under the *Customs (Dumping and Subsidies) Act 1965*.

7. *Provincial Government*: Provincial Governments are being established in Papua New Guinea and this process will continue during the lifetime of this National Investment Priorities Schedule. Certain powers presently exercised by and functions of the National Government are being transferred to Provincial Governments.

Investors will be advised by NIDA where transfers of authority have occurred and there will be close co-operation between the National Government, Provincial Governments and NIDA on decision-making on matters relevant to investment.

8. Foreign investment proposals should be desired by the people living in the areas in which they are to be located.

9. *Preferences for Joint Ventures*: Investment proposals from fully participatory joint ventures involving Papua New Guinean interests will be given more favourable consideration and, if approved, more advantaged terms and conditions of registration than firms which are wholly foreign owned at the time of application to NIDA.

10. Foreign investment proposals should not adversely affect the development of Papua New Guinean owned businesses.

11. *Takeovers*: In the case of proposals to take over existing businesses, NIDA may investigate the desirability and feasibility of the business being sold into Papua New Guinean ownership. Investors may expect this guideline to apply more commonly where foreign investment proposals have potential conflicts with guidelines 8 and 10.

In the evaluation of such proposals the maintenance by a successor enterprise of supplies and goods and services presently provided by an existing foreign owned enterprise will be recognised as a benefit.

12. A foreign enterprise wishing to engage in a new priority or open activity may be required to agree to conditions of registration relating to all or any of the following:

- (a) Government or Papua New Guinean equity participation; and
- (b) Training of Papua New Guineans for all levels of employment under a specific programme; and
- (c) Encouragement and assistance to Papua New Guineans in establishing related businesses; and
- (d) Utilisation of supplies and services available within Papua New Guinea; and
- (e) Environmental controls including measures to minimise harmful environmental effects, and payment for the cost of restoring the environment where it is damaged through the enterprise's operations; and
- (f) Fair trade practices.

GUIDELINES FOR SPECIFIC INDUSTRIES**Exploration for Minerals and Mining Development**

In addition to the general guidelines for new foreign investment the following guidelines apply to new foreign investment in mineral exploitation.

- (a) The Government has adopted the following three basic principles relating to the utilisation of mineral resources:
 - (i) minerals under the earth and water belong to the people of Papua New Guinea, and the Government and people must receive a fair price in return for the extraction of those materials;
 - (ii) foreign enterprises, whose expertise and capital are needed for commercial exploitation of mineral deposits should receive a reasonable return on their investment, but any extra-ordinary gains above a reasonable return on the investment will go in a very large part to the Government;
 - (iii) the Government has the right to regulate the activities of mining enterprises in such a way as will maximise the benefits of mining to the local community while minimising the potentially harmful social and economic costs.

Fourth National Investment Priorities Schedule—*continued*Chapter 5—*continued*

- (b) For large-scale exploration, Prospecting Authorities may be granted by the Minister for Minerals and Energy for periods of up to two years, with renewal dependent on satisfactory completion of agreed work programmes and satisfactory proposals for additional work to be performed.
- (c) The Government is prepared to enter into firm commitments to ensure the satisfactory establishment of a mine by way of a mining agreement with the investor covering the arrangements for each project and providing for the issue of a mining lease.
- (d) Major elements in the Government's consideration of proposals for mining agreements may include some or all of the following:
 - (i) a firm commitment to proceed with development of the project as rapidly as possible;
 - (ii) the developer to pay for required infrastructure;
 - (iii) satisfactory arrangements with respect to labour relations, training, environmental control, and other social issues;
 - (iv) proposals for Government equity participation;
 - (v) proposals for the processing of minerals within Papua New Guinea.
- (e) It is intended that general mining tax legislation will be introduced in the near future providing for normal rates of corporation tax to be levied and for an additional profits tax to be levied after the rate of return on a project achieves a specified reasonable rate of return.

Exploration for, and Development of, Petroleum Resources

In addition to the general guidelines for new foreign investment in Priority and Open activities, the following guidelines apply to new foreign investment in petroleum exploration and production:

- (a) Petroleum exploration and production will, as a matter of Government policy, be undertaken in the private sector and revenue to the Government will be derived largely from company income tax and an additional tax charged on cash flows after certain threshold returns have been achieved. The details of these taxes are contained in the Income Tax (Petroleum) Act, No. 72 of 1976, and the Income Tax (Additional Profits from Petroleum) Act, No. 71 of 1976. The Government will seek a carried interest for its negotiated share of the oil produced.
- (b) Petroleum Prospecting licences may be granted for either on-shore or off-shore areas under the 1977 Petroleum Act for an initial period of six years. Renewal will be dependent upon satisfactory completion of the programme carried out during the initial term, together with the submission to Government of acceptable work proposals for the extension period. One extension period only of five years may be granted, thus restricting the total term to eleven years maximum duration. The licence area to which the extensions apply may not exceed half the number of blocks in the licence (excluding discovery locations).

Agriculture

In addition to the general guidelines for new foreign investment a foreign enterprise wishing to engage in new agricultural activities may be required to agree to conditions of registration relating to all or any of the following:

- (a) encouragement and assistance to Papua New Guineans in cultivation of similar or identical agricultural products;
- (b) processing in Papua New Guinea of the agricultural product being cultivated.

Forestry

In addition to the general guidelines for new foreign investment, a foreign enterprise wishing to engage in new timber developments may be required to agree to conditions of registration relating to all or any of the following:

- (a) encouragement and assistance to Papua New Guineans in establishing businesses associated with the timber projects and directly connected with the main timber operations;
- (b) future land use in the area under consideration, through reforestation, agricultural activities, or some other form of development;
- (c) provision of new infrastructure or compensation to the Government for new infrastructure provided.
- (d) provision of export marketing expertise or access to export markets and guaranteed minimum export levels;
- (e) processing of timber extracted within Papua New Guinea;
- (f) a time programme for the establishment of all industrial plant and infrastructural facilities and minimum production levels;
- (g) if necessary, provision of a performance bond.

Fishing

In addition to the general guidelines for new foreign investment the following guidelines apply to new foreign investment in fishing:

- (a) New fishing activities by foreign enterprises in Papua New Guinea will normally be permitted only if they:
 - (i) take place in conjunction with the development of onshore facilities for processing the catch; or
 - (ii) are in support of, or integrated with, the activities of Papua New Guinean fishermen.
- (b) Licences to use a boat for fishing are issued for a calendar year and are renewable.
- (c) Investors may also be required to agree to conditions of registration relating to all or any of the following:
 - (i) encouragement and assistance to Papua New Guineans in all aspects of fishing, and in particular in establishing businesses associated with the main fishing projects;
 - (ii) inshore and offshore fishing to be undertaken by vessels manned by Papua New Guinean crews as soon as possible;
 - (iii) provision of new infrastructure for onshore projects, or compensation to the Government for new infrastructure provided;
 - (iv) provision of export marketing expertise, or access to export markets, or guaranteed minimum export levels;
 - (v) processing in Papua New Guinea of fish caught in Papua New Guinean waters;
 - (vi) a firm timetable for the establishment of all the further processing facilities and infrastructure agreed to between the developer and the Government;
 - (vii) if necessary, provision of a performance bond.

Construction

In addition to the general guidelines for new foreign investment the following guidelines apply to new foreign investment in the construction industry:

- (a) Investors should give preference to the utilisation of Papua New Guinean materials and where appropriate to techniques that use Papua New Guinean labour intensively.

Fourth National Investment Priorities Schedule—*continued*Chapter 5—*continued*

- (b) Investment proposals should, where appropriate, assist the development of Papua New Guinean firms (for example, by providing technical and management services), and provide development opportunities for such firms (for example, as sub-contractors).
- (c) Particular importance is attached to skill development. The general guideline on training will apply, but, in addition, the Government's response to a proposal will be influenced by the extent to which Papua New Guineans will learn by being directly involved in managerial and technological functions, by the extent to which the planned construction techniques use and develop general skills, and by any other special training characteristics.
- (d) Proposals should in general lead to increased Papua New Guinean ownership and participation in the construction industry.
- (e) The investor should expect to maintain a permanent establishment in Papua New Guinea unless there are exceptional circumstances such as irregular highly specialised contracts which prevent the Papua New Guinean market from supporting permanent staff and facilities.

Technical and Professional Services

In addition to the general guidelines for new foreign investment the following guidelines apply to new foreign investment in technical and professional services:

- (a) Proposals should contain an emphasis on training.
- (b) Investment is encouraged if:
 - (i) services are needed but are either absent or in short supply;
 - (ii) the investment will improve the functioning of key productive and developmental sectors in Papua New Guinea.
- (c) The investor should expect to maintain a permanent establishment in Papua New Guinea unless there are exceptional circumstances such as irregular highly specialised contracts which prevent the Papua New Guinea market from supporting permanent staff and facilities.

Shipping

In addition to the general guidelines for new foreign investment a foreign enterprise wishing to engage in shipping may be required to agree to conditions of registration relating to vessel operations as laid down by the Maritime Division, Department of Transport and Civil Aviation.

CHAPTER 6

EXEMPTION OF ENTERPRISES FROM REGISTRATION UNDER THE NATIONAL INVESTMENT AND DEVELOPMENT ACT

The Minister for Labour and Industry has exempted certain classes of foreign-enterprises from certain parts of the Act, subject in each case to certain conditions. In all cases where it appears that a foreign enterprise may be exempt, reference should be made to that issue of the *National Gazette* in which the full text of the exemption is published.

In all cases, exempted enterprises are required to notify NIDA of certain information, details of which are given in the particular issue of the *National Gazette*.

The classes of foreign enterprises to which exemptions apply at the date of publication are listed below:

1. Foreign enterprises exclusively engaged in drilling, seismic survey and other forms of exploration for minerals and hydrocarbons.

Exempt from Part VI of the Act (Control of Foreign Enterprises). *National Gazette* No. 10, 16th October, 1975.

2. Foreign enterprises exclusively engaged in providing services of any kind for the foreign enterprises specified in 1, above.

Exempt from Part VI of the Act (Control of Foreign Enterprises). *National Gazette* No. 10, 16th October, 1975.

3. Foreign enterprises exclusively engaged in the country in providing goods and services under a contract between the enterprise; and

(a) the State; or

(b) one or more statutory enterprises; or

(c) the State and one or more statutory enterprises.

Exempt from Part VI of the Act (Control of Foreign Enterprises). *National Gazette* No. 26, 25th March, 1976.

4. Foreign enterprises exclusively engaged in:

(a) general insurance business; or

(b) the business of a broker, within the meaning of the *Insurance Act 1974*.

Exemption from whole Act. *National Gazette* No. 26, 25th March, 1976.

5. Foreign enterprises with gross revenue of not more than K4 000.00 per year.

Exempt from Part VI of the Act (Control of Foreign Enterprises). *National Gazette* No. 61, 22nd July, 1976.

Enterprises are advised that the above exemptions may be amended in the future by the Minister for Labour and Industry. Any additional exemptions or the revocation of any of the above exemptions will be published in the *National Gazette*.
