

THE Honourable Member for Hagen Open, Mr Pius Wingti, proposes to alter the Constitution and, pursuant to the requirements of Section 14(2) (*making of alterations to the Constitution and Organic Laws*) of the Constitution, I, Kingsford Dibela, the Speaker of the National Parliament, hereby publish the proposed Law—

## THE INDEPENDENT STATE OF PAPUA NEW GUINEA

## PROPOSED LAW TO ALTER THE CONSTITUTION

entitled

*Constitutional Amendment No. 8.—Citizenship,*

Being a Law to alter the Constitution to provide that a naturalized citizen loses his citizenship if his spouse fails or refuses to be naturalized as a citizen within a specified period, and for related purposes,

MADE by the National Parliament.

## 1. CITIZENSHIP BY NATURALIZATION (AMENDMENT OF SECTION 67).

Section 67 of the Constitution is amended by—

(a) omitting Subsection (1) and substituting—

“(1) Subject to Subsections (4), (5) and (6) a person who has resided continuously in the country for at least eight years, may apply to the Minister responsible for citizenship matters to be naturalized as a citizen, and the Minister may, if he is satisfied as to the matters referred to in Subsection (2), in his deliberate judgement (but subject to Division 4 (*Citizenship Advisory Committee*), grant or refuse the application.”; and

(b) omitting from Subsection (2) the words “To be eligible for naturalization” and inserting in their place the words “Subject to Subsection (6), to be eligible for naturalization.”; and

(c) inserting after Subsection (3) the following—

“(4) A foreign female married to a citizen may be naturalized as a citizen on application in accordance with Section 69.

“(5) A married person shall not be naturalized as a citizen under Subsection (1) unless his application for citizenship includes his spouse, if the spouse is not already a citizen, and the spouse is to be granted citizenship at the same time his application is granted.

“(6) In the case of a female spouse of a male citizen given the right to apply for citizenship under Subsection (4) and Section 69(1), the requirements in—

(a) Subsection (1) (that an applicant must have resided in the country for eight years or more); and

(b) Subsection (2)(c) (that an applicant must speak and understand Pisin or Hiri Motu, or a vernacular of the country, sufficiently for normal conversational purposes)

may be taken into account but do not apply as the determining factors.

“(7) In order to avoid any ambiguity, it is hereby declared that all the qualifications under Subsections (1) and (2) apply, and Section 68(2) (*special provisions relating to naturalization*) shall be taken into account, in a decision on an application for naturalization by the male spouse of a naturalized female citizen.”.

## 2. SPECIAL PROVISIONS RELATING TO NATURALIZATION (AMENDMENT OF SECTION 68).

Section 68 of the Constitution is amended by inserting after Subsection (4) the following new subsection—

“(4A) A foreign female married to an automatic citizen and holds a foreign citizenship shall, for the purposes of determining her salary and other benefits and conditions of employment (if applicable) in the National Public Service, a State Service, a provincial government service or a statutory authority, be deemed to be a naturalized citizen.”.

Alteration to the Constitution—*continued*

## 3. APPLICATION FOR NATURALIZATION (AMENDMENT OF SECTION 69).

Section 69 of the Constitution is amended by omitting Subsection (1) and substituting—

“(1) Subject to Subsection (2), an application for naturalization under Section 67 (*citizenship by naturalization*) must be made—

- (a) in the case of a person who has resided continuously in the country for eight years or more before Independence Day—within two months after Independence Day; and
- (b) in the case of a foreign female married to an automatic citizen—at any time after the marriage; and
- (c) in the case of a foreign female married to a naturalized citizen—within two months of the marriage; and
- (d) in the case of any other person—within two months after the completion by him of eight years continuous residence in the country.”

## 4. AUTOMATIC LOSS OF CITIZENSHIP (AMENDMENT OF SECTION 70).

Section 70 of the Constitution is amended by inserting after Subsection (1) the following new subsection—

“(1A) A naturalized citizen automatically loses his citizenship if his spouse fails to apply for citizenship within the period prescribed under Section 69(1)(c) or (d) or, if an application is made by the spouse, the application is refused.”

## 5. TRANSITIONAL.

(1) The provisions of this section apply notwithstanding anything in the Constitution as amended by this law.

(2) Where the female spouse of a naturalized citizen had failed to exercise a right to apply for citizenship before the commencement of this law within the period prescribed by Section 69 of the Constitution, this law applies to give that spouse a right to apply for citizenship by naturalization within two months of this law coming into operation and her application shall be determined in accordance with the provisions of the Constitution as amended by this law.

(3) Where the spouse of a naturalized female citizen is required by Section 67(1) of the Constitution to reside in the country continuously for eight years or more and that spouse is not yet qualified under that provision the naturalized female citizen does not lose her citizenship until, after the eight year period, her spouse fails to apply for citizenship or his application is refused.

## AERATED WATERS—ARAWA, KIETA AND PANGUNA

MADE by a Deputy Price Controller under the provisions of the *Prices Regulation Act 1949*, to come into operation on the date of publication in the *National Gazette*.

## 1. CITATION.

This Order may be cited as Prices Order No. 222.

## 2. REVOCATION.

Prices Order No. 220 is hereby revoked.

## 3. DEFINITIONS.

In this Order—

"aerated waters" means aerated waters manufactured in Papua New Guinea or imported from overseas;

"retail" means for the purpose of consumption or use.

## 4. MAXIMUM RETAIL PRICE.

The maximum prices at which aerated waters may be sold by retail in Arawa, Kieta and Panguna are:—

(i) 330 ml and 285 ml refillable bottle—22 toea

(ii) 285 ml non-refillable bottle—27 toea

(iii) 370 ml can—29 toea
