COMMISSION OF INQUIRY

GREETING:—

Know you that I, Michael Thomas Somare, Prime Minister, reposing confidence in your integrity and ability, do, by virtue of the powers conferred by the *Commissions of Inquiry Act 1951* and all other powers me enabling, by this my Commission appoint you the said Mr Peter Charles White, Mrs Tamo Diro and Mr Himony Lapiso to be Commissioners under that Act, to inquire into and report upon a matter in which an inquiry would be, in my opinion, for the public welfare, that is to say to inquire into the basic causes of difficulties occurring on the University of Papua New Guinea Campus at Waigani, including the events occurring on the Campus and in its immediate vicinity in 1978 and in particular to consider and report on the following matters:—

- (a) the views of the Government and all interested persons or bodies, governmental or otherwise, on the matter; and
- (b) the problems highlighted by evidence given to the Commission; and
- (c) legislation relating to the control of the University and, in particular, the *University of Papua New Guinea Act 1965* and its effect in dealing with these problems; and
- (d) if the abovementioned Act is found to be ineffective, the measures, legislative and otherwise, that you consider would effectively deal with these problems; and
- (e) the areas in which it would be desirable for the Government to exercise greater control (if any); and
- (f) what problems of a social nature (if any) appear to limit the effective administration of the University.

AND I direct that the said Mr Peter Charles White shall be Chairman.

AND I further direct that the inquiry shall be held at Port Moresby.

AND I direct that the inquiry shall be held in public.

AND I further direct that you shall commence the inquiry with as little delay as possible and proceed therein with all dispatch and render to me your report on or before 28 November 1978.
