IT is hereby notified in accordance with Section 55(12) of the *National Investment and Development Act* that—

(a) under Sections 55(9) and 57(10) of the Act the Minister approved the registration of Jarwickham Estates Pty. Limited (in this notification called "the Enterprise") in respect of the following activities:
