Excise Tariff Amendment Act (Chapter 107)

ADJUSTMENT OF RATE OF DUTY

I, Philip Bouraga, Minister for Finance, by virtue of the powers conferred by Section 4 of the *Excise Tariff Amendment Act* (Chapter 107), and all other powers me enabling, hereby, in respect of the products specified below, adjust the rates of duty to that shown opposite with effect from 1st June, 1985.

Articles	Rate of Duty
1. Aerated water	K 0.154 per litre
2. Beer	K 0.736 per litre
3. Cigarette	K23.13 per kilogram
