

STATUTORY INSTRUMENT

I, Paul Pora, MBE., MP, Minister for Finance and Planning, by virtue of the powers conferred by Section 6(1)(c) of the National Provident Fund Act (Chapter 377) and all other powers me enabling, hereby revoke the appointment of Philip Aki as Trustee of the National Provident Fund Board and hereby appoint Ronney Agaru as Trustee of the National Provident Fund Board for a period of three (3) years.

STATUTORY INSTRUMENT

- I, Paul Pora, MBE., MP, Minister for Finance and Planning by virtue of powers conferred on me by Section 22 of the National Provident Fund Act (Chapter 337) and all other powers me enabling hereby:—
 - (a) Revoke all previous appointments of inspectors; and
 - (b) appoint the following officers and their designations specified in Columns 1 and 2 of the Schedule as inspectors; and
 - (c) determine that all inspectors shall:—
 - (i) exercise powers under Sections 23 and 24 of the Act; and
 - (ii) carry identification cards for purposes of verification.
