

I, WIWA KOROWI, G.C.M.G., K.St.J., Governor-General, by virtue of the powers conferred by Sections 7, 8 and 9 of the *Post and Telecommunication Corporation Act (Chapter 394)* as amended, acting with, and in accordance with, the advice of the National Executive Council, given after consideration of recommendations by the Minister for Communications hereby—
