Public Services (Management) Act 1986

REVOCATION OF APPOINTMENT OF DEPARTMENTAL HEAD OF DEPARTMENT OF CORRECTIVE INSTITUTIONS AND COMMISSIONER OF CORRECTIONAL SERVICES AND APPOINTMENT OF DEPARTMENTAL HEAD OF DEPARTMENT OF CORRECTIVE INSTITUTIONS AND COMMISSIONER OF CORRECTIONAL SERVICES
