Professional Engineers Registration Act 1986**NOTIFICATION OF REGISTRATION OF PROFESSIONAL ENGINEERS**

I hereby notify that the engineers specified in the schedule hereto are entitled to practice as professional engineers in accordance with part V of the Act and to use the identifying title 'Reg. Eng.' after their names. A person, Company, Statutory Body, Government Body, or Organisation which employs an un-registered person as a Professional Engineer is guilty of an offence.
