

Public Services (Management) Act 1986

APPOINTMENT OF DEPARTMENTAL HEAD OF DEPARTMENT OF CORRECTIVE INSTITUTIONAL SERVICES AND COMMISSIONER OF CORRECTIONAL SERVICES

I, Wiwa Korowi, G.C.M.G., K.St.J., Governor-General, by virtue of the powers conferred by Section 193(3) of the Constitution and Section 25 of the *Public Services (Management Act) 1986* and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, given after consultation with the Public Services Commission, hereby appoint Samson Nuakona to be Departmental Head of the Department of Corrective Institutional Services and Commissioner of Correctional Services for a period of four years commencing on and from the date of publication of this instrument in the *National Gazette*.

Harbours Board Act (Chapter 240)REVOCATION AND APPOINTMENT OF MEMBERS AND ALTERNATE MEMBERS OF THE PAPUA
NEW GUINEA HARBOURS BOARD

I, Wiwa Korowi, G.C.M.G., K.St.J., Governor-General, by virtue of the powers conferred by Sections 4(1)(d) and 4A of the *Harbours Board Act* (Chapter 240) and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, given after consideration of recommendations by the Minister, hereby—

- (a) revoke the appointments of David Waita, Adrian Haoda and Simon Ape as members and John Turumalum, Ruben Rambua and Dagia Babona as alternate members of the Papua New Guinea Harbours Board; and
- (b) appoint each of the persons specified in Column 1 of the Schedule to be a Member of the Papua New Guinea Harbours Board and the person specified in Column 2 of the Schedule to be the Alternate Member of the Board for the Member opposite his name for a period of two years,

with effect on and from the date of publication of this instrument in the *National Gazette*.

Organic Law on Provincial Government
