COMMISSION**

I, Wiwa Korowi, G.C.M.G., K. St. J., Governor-General, by virtue of the powers conferred by Sections 9, 10 and 11 of the *Papua New Guinea Sports Commission Act 1992* and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby:-

- (a) revoke the appointment of Nagora Bogan (who has resigned) as Chairman and Commissioner of Papua New Guinea Sports Commission Board; and
- (b) revoke the appointment of Donald Manoa as Deputy Chairman of Papua New Guinea Sports Commission Board; and
- (c) revoke the appointment of Bob Robertson (who has resigned) as Commissioner of Papua New Guinea Sports Commission Board; and
- (d) revoke the appointment of Sam Piniau as Alternate Commissioner of Papua New Guinea Sports Commission Board; and
- (e) appoint Donald Manoa to be the Chairman of Papua New Guinea Sports Commission Board; and
- (f) appoint Ton Blum to be the Deputy Chairman and Commissioner of Papua New Guinea Sports Commission Board; and
- (g) appoint Samson Piniau to be the Commissioner of Papua New Guinea Sports Commission Board; and
- (h) appoint Irong Noi to be the Alternate Commissioner of Papua New Guinea Sports Commission Board; and

for a period of three years commencing on and from the date of publication of this instrument in the *National Gazette*.
