Customs Tariff Act 1990

EXEMPTION FROM IMPORT DUTY

I, Wiwa Korowi, G.C.M.G., K. St.J., Governor-General, by virtue of the powers conferred by Section 9(1)(a) of the *Customs Tarrif Act 1990* and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby exempt from payment of import duty, with effect from the date of publication of this notice in the *National Gazette*, the goods specified in the Schedule subject to such conditions as are specified in the Schedule;—

1.	<p>Capital equipment, machinery, components and materials other than those locally produced or manufactured when imported into North Solomons Province solely for the purposes of the Bougainville Restoration Programme, subject to the following conditions:—</p> <p>(a) The imported goods may not be sold, disposed of, traded or removed from North Solomons Province within five years without the prior written approval of the Commissioner-General of Internal Revenue.</p> <p>(b) Such approval will be conditional on payment of duty, proportionate to the time remaining until expiry of the five year period.</p> <p>(c) The normal penalties for misdeclaration of goods, or contravention of the above, will apply.</p> <p>The exemption will remain in force until 30th June, 1996.</p>
2.	<p>Parts specifically designed for ships, boats and floating structures (except parts for pleasure yachts and sports-boats) when purchased and imported by Papua New Guinea registered companies.</p>
3.	<p>Goods other than those locally produced or manufactured, which are absolutely essential for the maintenance and administration of the official activities of the following organizations but not for sale, exchange or trade within five years, when imported by the following organisations and, where purchased out of duty free stock from a bonded warehouse, sale price does not exceed CIF value by more than 20%:—</p> <p>(a) National Capital District Commission;</p> <p>(b) National Broadcasting Corporation; and</p> <p>(c) The Cocoa Black Pod Research Trust, Karkar Island.</p>

National Water Supply and Sewerage Act 1986

Customs Tariff Act 1990**REDUCED RATES OF IMPORT DUTY**

I, Wiwa Korowi, G.C.M.G., K.
