

Customs Tariff Act 1990

EXEMPTION FROM IMPORT DUTY OF VARIOUS GOODS IN RELATION TO THE MADANG TUNA CANNERY

I, Bill Skate, M.P. Acting Governor-General, by virtue of the powers conferred by Section 9(1)(a) of the *Customs Tariff Act 1990* and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby exempt from import duty the goods specified in Schedule 1 subject to the conditions specified in Schedule 1 for the period specified in Schedule 2.

SCHEDULE 1

1. Goods imported by the Z Group and ZZZ Canning for the purposes of the Madang Tuna Cannery as specified in Appendix A—1 (other than Schedule 2) and Appendix A—2 to the Agreement between the Independent State of Papua New Guinea and Herea Dae Company No. 44 Pty., Ltd., (in the process of changing its name to ZZZ PNG Canning Pty Limited) (ZZZ Cannery) and the Madang Provincial Government and Big Z Fishing Company Inc., Chloe Z Fishing Company Inc., Don Juan Z Fishing Company Inc., Kassandra Z Fishing Company Inc., Margaret Z Fishing Company Inc., Marisa Z Fishing Company Inc., Milagros Z Fishing Company Inc., Larry Z Fishing Company Inc., Laura Z Fishing Company Inc., Soleil Z Fishing Company Inc., Yolanda Z Fishing Company Inc., J.M. Martinac Shipping Corporation.

Condition:

The exemption does not apply in respect of goods in relation to which there is a Comparable Product.

2. Goods imported by the Z Group and ZZZ Canning for the purposes of the Madang Tuna Cannery as specified in Appendix—3 to the Agreement referred to and fuels to be utilized by the Fleet.

Conditions:

The exemption applies only in respect of goods—

- (a) for subsequent export by the Cannery whether in processed form or otherwise; or
- (b) for the supply of ships' stores, aircraft stores and other requirements for the Fleet.

For the purpose of this Schedule, "Cannery", "Comparable Product",

"fleet" and "Z Group" have the meanings given to them by Clause 1.1 of the Agreement referred to.

SCHEDULE 2

The Project Life as that term is defined in the Agreement referred to in Schedule 1 hereto.
