## CONSTITUTION OF BOUGAINVILLE

### APPOINTMENT OF MEMBERS OF BOUGAINVILLE TRANSITIONAL ASSEMBLY

I, Julius Chan, Prime Minister, by virtue of the powers conferred by Section 114 of the Constitution of Bougainville and all other powers me enabling, hereby appoint, with effect from the date of publication of this instrument in the *National Gazette*, the following persons to be members of the Bougainville Transitional Assembly—

- (a) under Section 114 (1) (a), each person specified in Column 1 of Schedule 1 being the Chairman of the Interim Authority shown opposite his name in Column 2; and
- (b) under the provision specified in Column 1 of Schedule 2, each person specified in Column 2 opposite being a person nominated by the body shown in Column 3 opposite; and
- (c) under Section 114 (1) (e), each person specified in Column 1 of Schedule 3 to represent the constituency shown in Column 2 opposite, being a person nominated by the Interim Authority for the area in which the constituency is situated on the recommendation of the Council of Chiefs for that constituency; and
- (d) under Section 114 (1) (g), the persons specified in Schedule 4 to represent the National Government.
