*Fisheries Act 1994***DECLARATION OF SEDENTARY ORGANISMS**

I, Titus Philemon, Minister for Fisheries and Marine Resources, by virtue of the powers conferred by Section 2 (3) of the *Fisheries Act 1994* and all other powers me enabling, hereby—

- (a) revoke the previous notice of declaration of sedentary organisms dated 8th August, 1978, and published in the *National Gazette* No. G71 of 31st August, 1978; and
- (b) being satisfied that each marine organism specified in the Schedule forms part of the living natural resources of Papua New Guinea continental shelf and that it belongs to a sedentary species, hereby declare each of those organisms to be a sedentary organisms to which this Act applies.

Coffee Industry (Statutory Powers and Functions) Act 1991**MINIMUM QUALITY STANDARDS**
