

## REVOCATION OF SUPPLY AND TENDERS BOARDS

I, Chris Haiveta, MP., Deputy Prime Minister and Minister for Finance, by virtue of the powers conferred upon me by Section 39 of the *Public Finances* (*Management*) Act 1995, and all other powers me enabling, acting on the advice of the Secretary for Finance, hereby revoke the establishment of the following Supply and Tenders Boards:—

- (a) National Government Supply and Tenders Board; and
- (b) Works Supply and Tenders Board; and
- (c) Works Design Priorities Committee and Tenders Board; and
- (d) Plant and Transport Supply and Tenders Board; and
- (e) Police Supply and Tenders Board; and
- (f) Civil Aviation Supply and Tenders Board; and
- (g) Education Supply and Tenders Board; and
- (h) Overseas Mission Supply and Tenders Board.

### ESTABLISHMENT OF THE CENTRAL SUPPLY AND TENDERS BOARD

- I, Chris Haiveta, Deputy Prime Minister and Minister for Finance, by virtue of the powers conferred by Section 39 of the *Public Finances (Management) Act* 1995, and all other powers me enabling, acting on the advice of the Secretary for Finance, hereby:—
  - (a) establish a Central Supply and Tenders Board and appoint each of the following persons to be members of the Board:—

### Establishment of the Central Supply and Tenders Board—continued

- (i) Miri Setae who shall be the Chairman and
- (ii) Aphmeledy Joel, Deputy
- (iii) Paul Sai'i
- (iv) Lohia Hitolo
- (v) Brian Amini
- (vi) Angoea Tadabe
- (vii) Joe Gabut; and
- (b) the terms of appointment is for a period of two years. The appointments take effect immediately upon the date of publication of this instrument in the National Gazette.
- (c) Quorum.
  5 persons
- (d) Powers
  - (i) The Board may invite tenders for and on behalf of the State to an unlimited amount; and
  - (ii) To enter into and execute agreements or contracts up to the value of K5,000,000.00.
- (e) Purposes

CHARACTER SOLE

The Board may invite tenders for:-

- (i) the purchase of property and disposal of stores; and
- (ii) the supply of Works and Services; and
- (iii) the evaluation of proposals from consultants for professional and technical services as required and to implement capital works and maintenance programmes of National Government; and
- (iv) the setting of design priorities for both National and the Provincial Capital Works Programmes; and
- (v) to commission consultants to provide technical services on behalf of the State to a value estimated by the Board not exceeding the amount specified; and
- (vi) the supply of Works and Services peculiar to the operation of Civil Aviation.
