*Fauna (Protection and Control) Act (Chapter 154)***DECLARATION OF KAMIALI WILDLIFE MANAGEMENT AREA**

I, Paul Mambei, Minister for Environment and Conservation, by virtue of the powers conferred by Sections 15 and 16 of the *Fauna (Protection and Control) Act (Chapter 154)* and all other powers me enabling, having consulted—

- (a) with the owners of the Land described in Schedule 1; and
- (b) with the Local Government Council of the area with which the land is situated hereby—
- (c) declare the land described in Schedule 1 to be a Wildlife Management Area for the purposes of that Act; and
- (d) established a Wildlife Management Committee for that Wildlife Management Area; and
- (e) specify that the number of members of that Committee shall be 6; and
- (f) appoint each person specified in Schedule 2 to be a member of that Committee.

SCHEDULE 1

All those pieces of land as described below in two parts known as Kamiali Wildlife Management Area and having the total land and sea area of 47, 413 hectares or thereabouts situated in the Milinch of Morobe, Morobe Province. Firstly that piece of land being Morobe South Coast and the Hinterlands having an area of 29, 285 hectares or thereabouts commencing at a point being the southernmost corner of Kamiali WMA having the grid co-ordinates as 499, 500 metres east 9, 171, 800 metres north thence bounded generally on the southwest and northwest in a northerly direction for approximately 32, 000 metres to a point being the intersection with the left bank of Buyawin River downstream having the grid co-ordinates as 503, 000 metres east 9, 200, 000 metres north thence bounded on the said northwest by the said left bank of Buyawin River downstream for approximately 5, 000 metres to a point being the junctions with the left bank of Bitoi River having the grid co-ordinates as 505, 800 metres east 9, 200, 600 metres north thence bounded generally on the said northwest by the said left bank of Bitoi River downstream for approximately 13, 000 metres to the point being the High Water Mark of Solomon Sea having the grid co-ordinates as 514, 800 metres east 9, 200, 400 metres north thence bounded generally on the southeast northeast and northwest by the said High Water Mark in a southerly direction for approximately 23, 000 metres to a point on the said High Water Mark having the grid co-ordinates as 516, 000 metres east 9, 186, 400 metres north thence bounded generally again on the southeast by the right bank of Sela River upstream for approximately 21, 000 metres to a point being the Headwaters of the said Sela River having the grid co-ordinates 502, 500 metres 9, 174, 800 metres north thence bounded generally on the said southeast by the said Headwaters upstream for approximately 4, 500 metres to the point of commencement.

Secondly those pieces of land below the High Water Mark of the Solomon Sea including whole of Lababia Jawani and Batteru Islands having the total area of 18, 128 hectares or thereabouts commencing at a point being the said High Water mark having the grid co-ordinates as 514, 800 metres east 9, 200, 400 metres north thence bounded on the north by a straight line extending easterly for a distance of 12, 200 metres to a point having the grid co-ordinates as 527, 000 metres east 9, 201, 500 metres north thence bounded on the east by a straight line extending southerly for 15, 000 metres to a point having grid co-ordinates as 527, 000 metres east 9, 186, 400 metres north thence bounded on the south by a straight line extending westerly for a distance of 11, 000 metres to a point on the said High Water mark being the said right bank of Sela River having the grid co-ordinates as 516, 000 metres east 9, 186, 400 metres north thence bounded generally on the said southeast, southwest, southeast and northwest by the said high water mark in a northerly direction for approximately 23, 000 metres to a point of commencement be the said several dimensions all a little more or less and all grid co-ordinates and dimensions based on the Universal Transverse Mercators (UTM) in the 1:100, 000 Map series being the Wau and Nasau sheets and subject to survey.
