Fauna (Protection and Control) Act (Chapter 154)

DECLARATION OF KAVAKUNA CAVE WILDLIFE MANAGEMENT AREA AND APPOINTMENT OF MEMBERS OF THE KAVAKUNA CAVE WILDLIFE MANAGEMENT COMMITTEE

I, Paul Mambei, Minister for Environment and Conservation, by virtue of the powers conferred by Sections 15 and 16 of the Fauna (Protection and Control) Act (Chapter 154) and all other powers me enabling, having consulted:—

- (a) with the owners of the land described in Schedule 1; and
- (b) with the Local Government of the area with which the land is situated,

hereby:-

- (c) declare the land described in Schedule 1 to be a Wildlife Management Area for the purpose of that Act; and
- (d) establish a Wildlife Management Committee for that Wildlife Management Area; and
- (e) specify that the number of members of that Committee should be 7; and
- (f) appoint each person specified in Schedule 2 to be a member of that Committee; and
- (g) declare the rules specified in Schedule 3 to be the rules for the Wildlife Management Area.

SCHEDULE 1

The eastern site boundary starts at the confluence of the Kunapage and Matale Rivers estimated as E 335000, N 939400; follows the Kunapage River in a northerly direction to its headwaters estimated as E 338100, N 939950; then in a straight line to the intersection point of the Water Fall bay TRP with the Nutuve Timber area estimated as E 339000, N 9403200. The boundary heads due west to an arbitrary selected point defined as E 330000, N 9403200; then due south to an identifiable junction of the Matale River; a position estimated as E 330000, N 9397200. The south western boundary follows the Matale River to its confluence with the Kunapage Rivers.

SCHEDULE 3

Rules for the Kavakuna Caves Wildlife Management Area

- The Committee shall consist of 7 elected members elected by the representative of villages within the WMW, namely Marmar and Olaipuna villages. One member per clan from the 7 clans within the Area. Elections will be held every 2 years.
- 2. The Annual General meeting will be held in alternative villages each year. Minutes will be kept and signed by all present. Minutes will be sent to the Chief Executive of the PNG Tourism Promotion Authority, or its successor, for safe-keeping.
- The Committee will appoint a Business Management Group (BMG) consisting of 4 members with each of 3. the 2 villages having two members each.
- To conduct business the WMA Committee must have a quorum of at least 4 members. 4.
- Rules changes, in order to affect a change of WMA Rules all Committee members must be advised in writing of the meeting one week in advance, notice of the meeting posted in a prominent place in each village one week prior to the meeting. For a motion to be carried a two-thirds majority of those present is required.
- The Business Management Group will maintain a bank account at Palmalmal Station in the Pomio District. To protect against fraud, any withdrawal from the account must be countersigned by three designated members from different clans.
- Development approaches by outsiders, the Committee will discuss all offers with the Kavakuna Cave Business Work Group (KCBWG) a group of 3 members representing the PNG Tourism Promotion Authority, the Department of Environment and Conservation, and the East New Britain Tourism Board, or their legal successors.
- The WMA Committee will declare selective bans on the hunting of all animals as it sees fit. The 8. Committee will declare bans on cutting and clearing as it sees fit. The Committee will declare areas to be restricted. Access to the WMA shall be regulated.
- 9. The Committee may request the PNG Tourism Promotion Authority or its successor to assist in its dealings with outside agencies or to work with them to jointly manage the resources.
