Banking Corporation Act (Chapter 136)

REVOCATION OF APPOINTMENT OF CHAIRMAN, DEPUTY CHAIRMAN AND MEMBERS AND APPOINTMENT OF CHAIRMAN, DEPUTY CHAIRMAN AND MEMBERS

- I, Wiwa Korowi, G.C.M.G., K.St.J., Governor-General, by virtue of the powers conferred by Sections 10 and 16 of the *Banking Corporation Act* (Chapter 136) and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby—
 - (a) revoke the appointment of Thomas Negints as member and Chairman of the Papua New Guinea Banking Corporation Board; and
 - (b) revoke the appointment of Aivu Tauvasa as member and Deputy Chairman of the Papua New Guinea Banking Corporation Board; and
 - (c) revoke the appointment of the following members of the Papua New Guinea Banking Corporation Board—

LukeWomare William Nakin Daniel Inugu Paul Nili Robin Meriba George Mero

- (d) appoint Peter O'Neil to be the Chairman and Glen Kunden as Deputy Chairman of the Board in accordance with Section 16 of the Act for a period of 3 years; and
- (e) reappoint George Mero to be member of the Papua New Guinea Banking Corporation Board; and
- (f) appoint each person specified in Column 1 of the Schedule to be a member of the Papua New Guinea Banking Corporation Board for the period specified in Column 2 of the Schedule and set out opposite the name of that person.

Pime Minister Act (Chapter 27)

REVOCATION OF APPOINTMENT AND APPOINTMENT OF ACTING PRIME MINISTER

- I, Wiwa Korowi, G.C.M.G., K.St.J., Governor-General, by virtue of the powers conferred by Section 143(1) of the Constitution and Section 3(2) of the *Pime Minister Act* (Chapter 27) and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Counicl, hereby—
 - (a) revoke all the previous appointments of acting Prime Minister; and
 - (b) appoint Simon Kaumi, a Minister, to be the Acting Prime Minister for the period commencing on and from 28th October, 1997 until the resumption of duty of the Prime Minister or Deputy Prime Minister.
