CONSTITUTION

**AMENDMENT OF DETERMINATION OF TITLES AND RESPONSIBILITIES OF MINISTERS**

I, Bill Skate, Prime Minister, by virtue of the powers conferred by Section 148 of the Constitution, and all other powers me enabling, hereby amend the Determination of Titles and Responsibilities of Ministers dated 12th August, 1998, and published in *National Gazette* No. G90 on 14th August, 1998:—

- (a) in Schedule 4, in the heading and in Column 1, by deleting the word "Treasurer" and replacing it with the following:—  
"Deputy Prime Minister and Treasurer"; and
- (b) in Schedule 6, in the heading and in Column 1, by adding after the words "Minister for Public Enterprises" the following:—  
"and Minister assisting the Prime Minister on infrastructure and Public Investment Programme matters".
- (c) in Schedule 8:—
- (i) in the heading and in Column 1, by adding after the words "Foreign Affairs" the following:—  
"and Trade"; and
- (ii) in Column 2, in Paragraph (c), by adding the following Subparagraph:—  
"(iv) Department of Trade and Industry (insofar as relating to trade matters)."; and
- (iii) in Column 3, by inserting in alphabetical order in relation to the legislation already listed the following:—  
"Cocoa Act (Chapter 388)(insofar only as it relates to international trade).  
"Customs Act (Chapter 101)(Parts V and VI and Parts I and III exclusive of the Customs (Prohibited Imports) Regulations only).  
Customs (Dumping and Subsidies) Act (Chapter 118)  
Exports (Control and Valuation) Act (Chapter 108)"; and
- (d) in Schedule 9:—
- (i) in the heading by deleting the words "Deputy Prime Minister and Minister for Trade and Industry" and replacing them with the following:—  
"Minister for Commerce and Industry and Minister assisting the Prime Minister on economic matters"; and
- (ii) in Column 1, by deleting the words "Michael Nali—Deputy Prime Minister and Minister for Trade and Industry" and replacing them with the following:—  
"Ian Ling Stuckey—Minister for Commerce and Industry and Minister assisting the Prime Minister on economic matters"; and
- (iii) in Column 2, in Paragraph (a) by adding the following:—  
"(except trade matters)"; and
- (iv) in Column 3, by deleting the following:—  
"Cocoa Act (Chapter 388)(insofar only as it relates to international trade)  
"Customs Act (Chapter 101)(Parts V and VI and Parts I and III exclusive of the Customs (Prohibited Imports) Regulations only)  
Customs (Dumping and Subsidies) Act (Chapter 118)  
Exports (Control and Valuation) Act (Chapter 108)"; and
- (e) in Schedule 10, in Column 1, by deleting the name "Ian Ling Stuckey"; and
- (f) in Schedule 16, in Column 1, by deleting the name "Philemon Embel" and replacing it with the following:—  
"Masket Iangalio"; and
- (g) in Schedule 29, in Column 1, by deleting the name "Titus Philemon" and replacing it with the following:—  
"Andrew Kumbakor".
