Electricity Commission Act (Chapter 78)

REVOCATION OF APPOINTMENT OF COMMISSIONER AND APPOINTMENT OF COMMISSIONERS OF THE PAPUA NEW GUINEA ELECTRICITY COMMISSION

THE NATIONAL EXECUTIVE COUNCIL, by virtue of the powers conferred by Section 5 of the *Electricity Commission Act* (Chapter 78) and all other powers it enabling, on the recommendation of the Minister responsible for the Electricity Commission, hereby—

- (a) revokes the appointment of Tau Nana as Commissioner of the Papua New Guinea Electricity Commission under Section 5(1)(b)(ii); and
- (b) appoints each person specified in Column 2 of the Schedule to be a Commissioner of the Papua New Guinea Electricity Commission under the provision specified in Column 1 of the Schedule for a period of three years,

with effect on and from the date of publication of this instrument in the *National Gazette*.
