Land Act 1996ACQUISITION OF LAND BY COMPULSORY PROCESS

Land Act 1996CERTIFICATE OF NON-APPLICATION UNDER SECTION 13

I, Morris Alaluku, a delegate of the Minister for Lands, by virtue of the powers conferred by Section 13(6) of the *Land Act* 1996, and all other powers me enabling, hereby certify that there are special reasons why Section 13 of that Act relating to the acquisition of land by compulsory process should not apply to the land described in the Schedule, namely that as yet unresolved dispute over the ownership of the land dating back to 1970 precludes the accurate determination of ownership and, thereby, precludes the serving of the prescribed "Notice to Treat" and an expeditious resolution of purchase.
