## Vice-Ministers Act 1994

### DESIGNATION BY THE PRIME MINISTER OF MINISTERS TO BE ASSISTED BY VICE-MINISTERS AND OF THE DUTIES OF THE VICE-MINISTERS

Health	Ludger Mond	All health matters.
Foreign Affairs	Michael Laimo	Matters relating to Bougainville and such other matters as are specified by the Minister.
Corporatisation and Privatisation	Ajax Bia	Matters relating to Public Utilities.
Corporatisation and Privatisation	Baki Reipa	Matters relating to Financial Institutions.
