CERTIFICATION FOR LEGAL CLEARANCE

ON direction of the National Executive Council, I, Michael M Gene, Secretary for the Department of Attorney-General and the Attorney-General of Papua New Guinea by virtue of section 156(1)(a) of the Constitution and the provisions of the Attorney-General Act, hereby issue this circular to all State institutions, corporations and personnel intending to formalise and or execute contracts or agreements in any form or manner for purposes of providing goods and or engaging services to the State, to seek a Certificate of Legal Clearance from the Office of the Attorney-General before committing the State.

A Certificate of Legal Clearance should also be sought on all NEC policy submissions and in particular, the Department of Attorney-General is to provide the Legislative and Legal Implications of every policy submission.

Procedure to seek Certification of Legal Clearance

Prepare draft documentation.

- Forward a copy of the draft documentation to the Office of the Attorney-General.
- The Attorney-General comments on the legal matters and refers the draft documentation to the sponsoring agency.
- The sponsoring agency then incorporates the legal implications into the documentation.
- After the documentation is finalised, these are again referred to the Attorney-General for the Certificate of Legal Clearance.

On the matters affecting the conduct of the business of the State where legal issues arise or might arise, the Certification of Legal Clearance is only issued by the Attorney-General to the exclusion of all other lawyers. This means that I must still give my clearance even if other in-house lawyers have provided their advice and opinions.
