The effect of this Prices Order is to increase the Ex-factory price (per carton) of locally canned Mackerel fish (Besta & Supreme) products as follows:

- 1. 425g cans (Besta & Supreme) to increase by 20%;
- 2. 180g/200g cans (Besta & Supreme) to increase by 15% and
- 3. 155g cans (Besta & Supreme) to increase by 30%.

The approved increases are to be apportioned and applied in two-stages as shown under Columns 2 and 3 above. The above prices are exclusive of Value Added Tax.
