*Public Finances (Management) Act No. 21 of 1995*

**ESTABLISHMENT OF THE NATIONAL FISHERIES AUTHORITY SUPPLY AND TENDERS BOARD**

I, Andrew Kumbakor, MP., Minister for Finance, National Planning and Monitoring and Rural Development, by virtue of the powers conferred by Section 39 of the *Public Finances (Management) Act No. 21 of 1995*, acting with, and in accordance on the advise of the Department responsible for the financial management and all the powers me enabling, hereby:—

- (a) Give approval to effect the establishment of the National Fisheries Authority Supply and Tenders Board and appoint each of the following persons to be Members of the Board.
- (i) The Managing Director of National Fisheries Authority as Chairman,
  - (ii) Financial Controller National Fisheries Authority, Member,
  - (iii) Manager — Corporate Services National Fisheries Authority, Member,
  - (iv) Manager — Monitoring & Enforcement National Fisheries Authority, Member and;
  - (v) Legal Services Officer National Fisheries Authority, Member.
- (b) Appoint as alternate Members for each of the following Members of the Board:—
- (i) In the case of Managing Director National Fisheries Authority, (Chairman), Deputy Managing Director National Fisheries Authority, (Deputy Chairman),
  - (ii) In the case of Financial Controller National Fisheries Authority, Manager — Projects National Fisheries Authority,
  - (iii) In the case of Manager Corporate Services National Fisheries Authority, Provincial & Industry Liasion Advisor, National Fisheries Authority,
  - (iv) In the case of Manager Monitoring & Enforcement National Fisheries Authority, Team Leader - Enforcement National Fisheries Authority; and
  - (v) In the case of Legal Officer National Fisheries Authority, Fisheries Management Advisor National Fisheries Authority.
- (c) Quorum
- The quorum shall be three (3) members of the Committee one of who shall be the Chairman or the Deputy Chairman.
- (d) Powers
- (i) The Financial Limit of the National Fisheries Authority Supply and Tenders Board is unlimited for the inviting of tenders for and on behalf of National Fisheries,
  - (ii) The Financial Limit for the award of contracts is limited to Kina Three Million (K3,000,000.00) only
  - (iii) The Chairman or the Deputy Chairman shall execute Contracts and Agreements for and on behalf of the National Fisheries Authority Supply and Tenders Board upto the Financial Limit in (d)(ii) hereabove.
- (e) Rules and Criteria

The Board shall comply with the requirement of part 9 Division 1 and Part 10 Divisions 1, 2, 3 and Appendix 1 of the Financial Instructions (January 2001), save and except that, (i) for Contracts and Agreements upto the Financial Limit of the Board the Legal Officer Fisheries Management Authority shall exercise the power to draw up contracts, and, (ii) all Contracts in excess of the value of the delegated financial limit in (d)(ii) shall be referred to the Central Supply and Tenders Board for consideration and for the issue of a Decision.
