REGISTERED POLITICAL PARTIES

SECTION 20 OF THE ORGANIC LAW ON THE INTEGRITY OF POLITICAL PARTIES AND CANDIDATES REQUIRES THE REGISTRAR TO PUBLISH IN THE NATIONAL GAZETTE THE LIST OF ALL REGISTERED POLITICAL PARTIES SOON AFTER THE ISSUE OF WRITS FOR AN ELECTION TO PARLIAMENT.

THIS REQUIREMENT UNDER SECTION 20 IS TO ENFORCE THE INTENTION OF SECTION 6 OF THE ORGANIC LAW WHICH CLEARLY STATES THAT ONLY REGISTERED POLITICAL PARTIES ARE ELIGIBLE TO NOMINATE OR ENDORSE CANDIDATES FOR ELECTION TO PARLIAMENT.

THESE REGISTERED POLITICAL PARTIES ARE BEING GAZETTED, DUE TO THE 6TH SUPPLEMENTARY ELECTIONS IN THE SOUTHERN HIGHLANDS.

THE FOLLOWING POLITICAL PARTIES WHO HAVE LODGED THEIR APPLICATIONS IN ACCORDANCE WITH THE REQUIREMENTS OF SECTION SEVEN (7) AND HAVE SUBSTANTIALLY MET THE OTHER REQUIREMENTS OF THE ORGANIC LAW AND HAVE BEEN GRANTED APPROVAL FOR REGISTRATION BY THE CENTRAL FUND BOARD OF MANAGEMENT.

B. NOMINATION AND ENDORSEMENT OF CANDIDATES

POLITICAL PARTIES ARE TO NOMINATE AND ENDORSE ONLY ONE CANDIDATE FOR EACH ELECTORATE. SECTION SIXTY (60) STATES THAT A REGISTERED POLITICAL PARTY SHALL NOT ENDORSE MORE THAN ONE CANDIDATE (WHETHER MALE OR FEMALE) IN EACH ELECTORATE.

ENDORSEMENT HERE MEANS FINANCIAL AND OTHER LOGISTICAL SUPPORT TO A CANDIDATE. THE ELECTORAL COMMISSION AND HIS OFFICIALS ARE HEREBY ADVISED OF THESE REGISTERED POLITICAL PARTIES ARE NOT TO ASSIST IN ENFORCING THE PROVISIONS OF THE ORGANIC LAW ON THE INTEGRITY OF POLITICAL PARTIES AND CANDIDATES.

THIS IS TO CERTIFY THAT ALL THE POLITICAL PARTIES LISTED HERE HAVE BEEN DULY REGISTERED, UNDER SECTION 26 OF THE ORGANIC LAW ON THE INTEGRITY OF POLITICAL PARTIES AND CANDIDATES AND ARE ELIGIBLE TO NOMINATE OR ENDORSE CANDIDATES FOR THE 2003 SUPPLEMENTARY NATIONAL ELECTIONS IN SOUTHERN HIGHLANDS.
