National Capital District Water Supply and Sewerage Act 1996

TARIFFS RATES FEES AND CHARGES (OCCUPIER ACCOUNTS) DETERMINATION

NCD WATER SUPPLY AND SEWERAGE LIMITED, by virtue of the provision of Sections 24(3) and 31 of the *National Capital District Water Supply and Sewerage Act 1996*, and all other powers it enabling, hereby makes the following determination in respect of the method of account opening and payment by non owner occupiers for tariffs, rates fees and charges ("rates") to be made for water and services supplied by the Company.

Non Owner Responsible Accounts.

This determination affects the method of payment of rates by non-owner occupiers of properties.

1. The primary responsibility for payment of rates lies with the registered owner of the property and the registered owner shall be liable for all rates, except where the Company holds a bond in respect of a current occupier account for a property.
2. If the owner wishes to make a non-owner occupier ("the occupier") of a property responsible for the rates, the owner shall ensure that an application for an occupier account is lodged with the Company by the occupier endorsed with the owners consent, and in the form approved by the Company.
3. Every applicant for an occupier account in respect of a property shall pay to the Company a bond in a sum of K200 or such greater appropriate amount as determined by the Company ("the bond"), as a security for the payment of the rates. The bond shall be maintained at all times during the tenure of the occupier.
4. Upon an occupier giving notice in writing to the Company, that the occupier will cease occupation of the property from a date not closer than 5 working days from receipt of the notice by the Company, a refund of the bond will be made. There will be deducted from the bond any unpaid rates accrued under the occupier account. Where the Company is not given 5 days notice of cessation of occupation the Company is entitled to charge the occupier account the rates accruing for five days following actual receipt of the notice.

 - a. The Owner shall pay to the Company the fee for and apply for installation of a new meter;
