*Liquor (Licensing) Act (Chapter 312)***RESTRICTION OF SUPPLY OF LIQUOR**

I, Peter Barter, Minister for Inter-Government Relations, by virtue of the powers conferred by Section 27 of the *Liquor (Licensing) Act* (Chapter 312) and all other powers, me enabling, in consultation with the Liquor Licensing Commission, hereby restrict the sale or supply of liquor on premises which are subject of licence or permit under the Act in all Provinces of the country wherein:-

- (a) all liquor license/permit holders, other than Publican license holders, Limited Hotel Licence holders and Club Licence holders, shall not sell, supply or dispose of liquor on their permises:-
  - (i) on Saturday, 25th December, 2004; and
  - (ii) on Friday 31st December, 2004; and
  - (iii) on Saturday 1st January, 2005; and
- (b) Publican License holders shall sell, supply and dispose of liqor on the licenced premises only in the hours from:-
  - (i) 11.00 a.m. to 2.00 p.m., and 4.30 p.m. to 8.00 p.m. on Saturday 25th December, 2004; and
  - (ii) 4.30 p.m. to 8.00 p.m. on Friday 31st December, 2004; and
  - (iii) 11.00 a.m. to 2.00 p.m. and 4.00 p.m. to 8.00 p.m. on Saturday 1st January, 2005; and
- (c) Limited Hotel license holders and Club license holders shall sell, supply and dispose of liquor on the licensed premises only in the hours from:-
  - (i) 11.00 a.m. to 2.00 p.m. and 4.00 p.m. to 8.00 p.m. on Saturday 25th December, 2004 and Friday 31st December, 2004; and
  - (ii) 11.00 a.m. to 1.30 p.m. and 4.00 p.m. to 7.00 p.m. on Saturday 1st January, 2005.
