**DECLARATION OF PROPOSED PROVINCIAL WAMA-BAIDA-WOITAPE ROAD**

I, Raphael Yibmaramba, MBE., Provincial Administrator, authorized by the Central Provincial Executive Council (PEC) to make this declaration for and on-behalf of the Central Provincial Government the proposed Wama-Baida-Woitape road as a Provincial Road. The declaration is made as per the PEC Decision No. 46/2003, Meeting No. 14/2003, dated 28th August, 2003.

The proposed Wama-Baida 40 meter wide road route to link Waitape Government Station commences at Doa Rubber Plantation along the Hiritano Highway at a junction located approximately 100 kms west of National Capital District (NCD). From the junction the road commences thence northerly and northeasterly for approximately 1.1 km northwesterly to the foot of a Hill marked 103 for approximately 1.2 km thence northwesterly through and around Lolorua Rubber Plantation for approximately 2.7 km thence northerly to Aroa River for approximately 1.1 km thence northeasterly along the Aroa River for approximately 4.4 km again going northeasterly crossing the Aroa River for approximately 1.2 km again northeasterly passing between ASL mark .312 generally on the west and .347 on the east for approximately 14.5 km again northerly for approximately 2 km northeasterly for approximately 3.6 km thence easterly for approximately 1.5 km thence northerly for approximately 2.5 km thence northeasterly for approximately 1.5 km and easterly for approximately 2 km thence northeasterly for approximately 11.5 km thence northwesterly to the bend in alignment with ASL 1611 on the east for approximately 2 km thence northeasterly to the proposed intersection for Fane and Waitape Road for approximately 0.5 km thence southeast of Avele Village and south of Karame Village at the Head of Dilava River thence easterly for approximately 2.5 km northerly for approximately 0.6 km thence northeasterly for approximately 3 km thence easterly for approximately 1.6 km thence northeasterly for approximately 2.5 km thence northerly for approximately 1 km thence southeasterly for approximately 2 km again northeasterly for approximately 5 km thence southeasterly for approximately 2.5 km and northeasterly for approximately 5 km thence southeasterly for approximately 1.5 km and northeasterly for approximately 3.5 km to the end of the route at point marked by "P" being an intersection of Ononge-Woitape Road, covering a total length of approximately 85.5 km ending at Waitape Government Station.
