*Telecommunications Act 1996***NOTIFICATION OF GOVERNMENT POLICY**

THE Independent Consumer and Competition Commission (the Commission), the principal regulator of the *Telecommunications Act 1996* (the Act), and the Papua New Guinea Radiocommunications and Telecommunications Technical Authority (PANGTEL), the regulator of technical matters under the Act, have been notified of a Government Policy relating to telecommunications.

The Commission has been notified in writing, in accordance with Section 191 of the Act, and PANGTEL has been notified in writing, in accordance with Section 36 of the Act, by the Prime Minister, as Minister responsible for telecommunications, of a Government Policy relating to telecommunications which has been approved by the National Executive Council.

The Government Policy is that:—

- (1) Two new Public Mobile Telecommunications Licences should be issued by the Independent Consumer and Competition Commission after the expiry of the Telikom PNG Limited mobile monopoly period, to successful bidders,
- (2) The new licences will be issued by the Independent Consumer and Competition Commission after the monopoly period has been changed by agreement with Telikom PNG Limited and after the tender processes are carefully carried out and completed,
- (3) The Independent Consumer and Competition Commission, as the independent regulator responsible for the issuing of telecommunications licences, is to conduct a closed tender process, including inviting Thaicom/Shin Satellite, Telstra, Singtel, Optus and others, to determine the successful bidders, and
- (4) Mandatory network roll out arrangements will be declared conditions in all mobile licences under Section 63 of the *Telecommunications Act 1996*, which will thus apply to the new licencees and to Telikom.

The Commission and PANGTEL are required, by Section 191(2) and 36(2) respectively, of the Act, to ensure that this Government Policy is carried out.

**AMENDMENT TO NOTICE OF DECLARATION OF THE  
PORT OF WEWAK**

I, Sir Rabbie L. Namaliu, KCMG, Minister responsible under the *Harbours Act (Chapter 240)* (as amended), having received the recommendation of the delegate of the Departmental Head responsible for transport matters pursuant to Section 15H of the *Harbours Act (Chapter 240)* by virtue of the powers conferred by Section 2 of the *Harbours Act (Chapter 240)* (as amended), and all other powers me enabling, hereby amend the declaration of the Port of Wewak dated 17th December, 1976 and published in *National Gazette* No. G1 on 1st January, 1977 by omitting from Schedule 3 the words "Port of Wewak" and the limits of that port there declared and replacing them with the words in the Schedule.

**SCHEDULE**

**"Port of Wewak"**
