1. Landen Group Limited (in this Petition called "the Company") was on the 14th day of June, 1977 incorporated under the *Companies Act*.
2. The registered office of the Company is Sinton Spence, 2nd Floor, Brian Bell Plaza, Turumu Street, Boroko, National Capital District, Papua New Guinea.
3. The Company is indebted to the Petitioner for the amount of K17,250.90 been the amount due by the Company to the Petitioner for the provision of legal services provided to the Company at the Company's request between 1st January, 2001 and 31st December, 2003.
4. The Petitioner has on the 26th May, 2005 served upon the Company, a Creditor's Statutory Demand for Payment of Debt (Form 42) for an amount of K17,250.90 and the Company has for in excess of one month thereafter failed or neglected to pay the sum claimed or to compromise the debt to the satisfaction of the Petitioner.
5. The Company is unable to pay its debts.

YOUR PETITIONER THEREFORE HUMBLY PRAYS:—

- (1) That Landen Group Limited be wound-up by the Court under the provisions of the *Companies Act*.
- (2) That Rex Paki of RAM Business Consultants be appointed Liquidator for the purposes of the winding-up.
- (3) That the Bank in which the Liquidator is to open a Trust Account be Australian & New Zealand Banking Group (PNG) Ltd, Port Moresby branch.
- (4) That the Liquidator pay the Petitioner's costs of and incidental to this Petition to be taxed on a common fund basis;
- (5) That leave be given to abridge time for entry of this order to the time of settlement by the Registrar which shall take place forthwith.
