 - (v) to raise funds through child sponsorship for carrying out the objects of the Association or to promote or further any of the charitable or philanthropic purposes referred to herein;
 - (vi) to exercise the powers set forth in Section 124(1) of the Act except where they are inconsistent with any other clauses contained in this Constitution;
 - (vii) to solicit and to receive voluntary contributions and raised funds throughout the world, and transmit such funds and any income thereon throughout the world for the purpose of carrying out the objects of the Association; and
 - (viii) to do all such other things as are incidental or conducive to the attainment of the objects of the Association and for such purposes to exercise any of the forgoing powers,
- to the extent that these objects are charitable under the laws of each State or Territory of Australia.
- (b) The association will apply its profits (if any) or other income in promoting its objects.
- (c) The association will prohibit the payment of any dividend or payment in the nature of a dividend to its members.
