## REVOCATION AND APPOINTMENT OF NEW MEMBERS AND ALTERNATE MEMBERS OF THE NATIONAL EDUCATION BOARD

- I, Michael Laimo, CBE., Minister for Education, by virtue of the powers conferred by Sections 10, 11, 12 and 15 of the Education Act 1983, and all other powers it enabling, hereby:—
  - (a) revoke the appointment of the following current members and alternate members of the National Education Board:—
    - (i) Murray Paiva PNGTA member; and
    - (ii) Dennis Kabekabe Church member; and
    - (iii) Leonard Kinminja Church member; and
    - (iv) Jenny Nindil Highlands Region alternate member; and
    - (v) Bernadette Ropa Islands Region alternate member; and
    - (vi) Tuwe Olewale Southern Region alternate member; and
    - (vii) Roger Baboa Church alternate member; and
    - (viii) Sr. Helen Warman Church alternate member; and
    - (ix) Kila Amini Business and Civic alternate member; and
  - (b) appoint each person specified in Column 1 of the Schedule to be a member of the National Education Board; and
    - (i) under the Section of the Act and to represent the organization specified in Column 2 of the Schedule opposite the name of that person; and
    - (ii) to hold office for the period specified in Column 3 of the Schedule opposite the name of that person; and
  - (c) appoint each person specified in Column 4 of the Schedule to be the alternate member of the member whose name is specified in Column 1 of the Schedule opposite the name of that alternate member.
