I, Grand Chief Sir Michael Thomas Somare, Prime Minister, by virtue of the powers conferred by Section 2, 4A and 18 of the *Commissions of Inquiry Act* (Chapter 31) and all other powers me enabling, hereby:—

- (a) Revoke—
 - (i) the notice of Determination of Terms and Conditions of the Counsel Assisting the Commission of Inquiry dated 16th January, 2008 and published in *National Gazette* No. G7 of 17th January, 2008; and
 - (ii) the notice of Revocation and Determination of other Staff to Assist a Commission of Inquiry dated 16th January, 2008 and published in the *National Gazette* No. G7 of 17th January, 2008; and
- (b) Establishment of Offices
Establish the positions contained in the Inquiry Structure specified in Schedule 1 for personnel engaged for purposes of the Inquiry; and
- (c) Sanction of Payment of Remuneration
Sanction the payment of remuneration specified in Column 2 of Schedule 2 for the position holder shown opposite in Column 1 engaged for the purposes of the Inquiry subject to the following:—
 - (i) where the position holder is a Public Servant, the amount payable is the rate per day as specified in Column 2 less the amount received per day by the position holder as a Public Servant; and
 - (ii) the remuneration of the position holder is subject to the *Income Tax Act* 1959; and

and hereby further Determine that —

- (d) the Chief Secretary may, on the recommendation of the Secretary assisting the Inquiry, by notice under his hand —
 - (i) engage from time to time personnel required to occupy the positions specified in Schedule 1 as are necessary for the purposes of the Inquiry; and
 - (ii) approve the establishment of an additional position where more than one person is required to be engaged to perform the duties of a particular position,


