AMENDMENT OF DETERMINATION OF TITLES AND RESPONSIBILITIES OF MINISTERS

I, Michael Thomas Somare, Prime Minister, by virtue of the powers conferred by Section 148 of the Constitution and all other powers me enabling, hereby amend with, effect on and from 26th August, 2009, the Determination of Titles and Responsibilities of Ministers dated 13th September, 2007 and published in the *National Gazette* No. G145 of 13th September, 2007 (as amended)—

- (a) in Schedule 1 (Prime Minister and Bougainville Affairs) in Column 3 by deleting Paragraph (n); and
- (b) in Schedule 3 (Minister for Works, Transport and Civil Aviation)—
- (i) by deleting the heading and replacing it with the following:—
“Schedule 3—Minister for works and Transport”; and
 - (ii) in Column 1, by deleting “Don Polye” and inserting “Sir Michael Thomas Somare”; and
 - (iii) in Column 4, by deleting “*Civil Aviation Act 2000*” and “*Civil Aviation Aircraft Operators Liability Act (Chapter 292)*”; and
- (c) by adding after Schedule 28 the following Schedule:
“Schedule 29—Minister for Civil Aviation”

*Organic Law on Provincial Governments and Local-level Governments**Public Services (Management) Act 1995***REVOCATION OF ACTING APPOINTMENT AND APPOINTMENT OF PROVINCIAL ADMINISTRATOR**

THE NATIONAL EXECUTIVE COUNCIL, by virtue of the powers conferred by—

- (a) Section 73(2B) of the *Organic Law on Provincial Governments and Local-level Governments* and Section 60B of the *Public Services (Management) Act 1995* and all other powers it enabling, in accordance with a recommendation from the New Ireland Provincial Executive Council, and in accordance with a recommendation from the Public Services Commission following procedures prescribed by or under the *Public Services (Management) Act 1995*, hereby revoke the appointment of Veronica Jigede as Acting Provincial Administrator for New Ireland Province; and
- (b) Section 73(2) of the *Organic Law on Provincial Governments and Local-level Governments* and Section 60 of the *Public Services (Management) Act 1995* and all other powers it enabling, from a list of three persons submitted by the New Ireland Provincial Executive Council from a list of persons recommended to the Provincial Executive Council by the Public Services Commission, following procedures prescribed by or under the *Public Services (Management) Act 1995*, hereby appoint Simeon Malai as Provincial Administrator of New Ireland Province for a period of four years,

with effect on and from 12th January, 2009.
