APPOINTMENT OF CHAIRMEN AND DEPUTY CHAIRMEN OF VILLAGE COURTS

I, Hon. Bire Kimisopa, Minister for Justice, by virtue of the powers conferred by Section 18(1) of the Village Court Act 1989 and all other powers me enabling, hereby:—

Appointment of Chairmen and Deputy Chairmen of Village Courts-continued

- (a) appoint each Village Magistrates specified in Column 2 of the Schedule to be the Chairman of the Village Court specified in Column 1 and set out opposite the name of that Village Magistrates; and
- (b) appoint each Village Magistrates specified in Column 3 of that Schedule to be the Deputy Chairman of the Village Court specified in Column 1 opposite the name of that Village Magistrate
