EXEMPTION FROM IMPORT DUTY.

I, SIR MICHAEL OGIO, G.C.M.G., K. St. J., Governor-General, by virtue of the powers conferred by Section 9(1)(a) of the Customs Tariff Act 1990 and Section 3(1)(a) Excise Tariff Act (Chapter 107) and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby exempt from import duty and exempt from excise tariff, duty list of equipments, machinery and materials specified in the Schedule for the purposes of the Bewani Oil Palm Project Agreement between the Independent State of Papua New Guinea and Bewani Oil Palm Plantations Limited.
