APPOINTMENT OF MEMBERS AND ALTERNATE MEMBERS OF THE NATIONAL INSTITUTE OF STANDARDS AND TECHNOLOGY COUNCIL

- I, Sir Michael Ogio, G.C.M.G., K.St.J., Governor-General, by virtue of the powers conferred by Sections 8 and 9 of the *National Institute of Standards and Industrial Technology Council Act* 1993 and Section 10 of the *Regulatory Statutory Authorities* (Appointments to Certain Offices) Act 2004, and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby:—
