## **REVOCATION OF APPOINTMENT OF DIRECTOR-GENERAL AND APPOINTMENT OF A DIRECTOR-GENERAL OF THE NATIONAL INTELLIGENCE ORGANIZATION**

I, Ano Pala, C.M.G.; Acting Governor-General, by virtue of the powers conferred by Sections 8(1)(a) and 9 of the *National Intelligence Organization Act* 1984 and Section 31B and 31C of the *Public Services (Management) Act* 1995 and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, given after consultation with the Leader of the Opposition, hereby:—

- (a) revoke the appointment of Robert Nenta as Director-General of National Intelligence Organization published in the *National Gazette* No. G228 of 19th November, 2009; and
- (b) appoint Bruno Maika as Acting Director-General of the National Intelligence Organization for a period of three months, commencing on and from 12th January, 2012.
