EXEMPTION FROM IMPORT AND EXCISE DUTIES FOR ILLI-WAWAS INTERGRATED RURAL DEVELOPMENT PROJECT

- I, GRAND CHIEF SIR MICHAEL OGIO, GCL., G.C.M.G., K. St. J., Governor-General, by virtue of the powers conferred by Section 9(1)(a) of the *Customs Tariff Act* 1990 and Section 3(1)(a) of the *Excise Tariff Act* (Chapter 107) and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby
 - (a) exempt from import duty; and
 - (b) exempt from excise tariff,

the import of additional Machineries, Equipment and Materials to the current exempted list in the *National Gazette* No. G12 of 15th January, 2013.
