TEMPORARY OF DETERMINATION OF TITLES AND RESPONSIBILITIES OF MINISTERS

I, PETER O'NEILL, Prime Minister, by virtue of the powers conferred by Section 148 of the Constitution and all other powers me enabling, hereby —

- (a) revoke the determination published in the *National Gazette* No. G299 dated 4th May, 2015; and
- (b) determine that the Minister for Sports and Pacific Games shall have the responsibilities of the Minister for Tourism, Arts and Culture, commencing on and from the publication of this instrument in the *National Gazette* up until such time a permanent determination is made.

AMENDMENT OF DETERMINATION OF TITLES AND RESPONSIBILITIES OF MINISTERS

I, PETER O'NEILL, Prime Minister, by virtue of the powers conferred by Section 148 of the Constitution and all other powers me enabling, hereby amend the Determination of Titles and Responsibilities of Ministers dated 10th August, 2012 and published in the *National Gazette* No. G304 of 10th August, 2012 (as amended) —

- (a) in Schedule 1 (Prime Minister) —
 - (i) Column 3 by —
 - (A) inserting the following:
 - (I) All matters relating to Autonomy and Bougainville Peace and Restoration Office and restoration and reconstruction on Bougainville and foreign funding relative thereto; and
 - (II) Office of Urbanization; and
 - (III) National Events; and

- (B) deleting the following:
 - (I) Kumul Petroleum Holding Limited; and
 - (II) Kumul Minerals Holding Limited; and
- (ii) Column 4 by —
 - (A) inserting “All legislation relating to Autonomy and Bougainville Matters”; and
 - (B) deleting —
 - (I) *Kumul Petroleum Holdings Limited Authorisation Act 2015*; and
 - (II) *Kumul Minerals Holdings Limited Authorisation Act 2015*; and
- (b) in Schedule 4 (Minister for Public Enterprises and State Investments), Column 1, by deleting Ben Micah and inserting William Duma; and
- (c) in Schedule 6 (Minister for Transport and Infrastructure), Column 1, by deleting William Duma and inserting Nixon Duban; and
- (d) in Schedule 17 (Minister for Petroleum and Energy) —
 - (i) Column 1, by deleting Nixon Duban and inserting Ben Micah; and
 - (ii) Column 3, by inserting —
 - (A) “Kumul Minerals Holding Limited”; and
 - (B) “Kumul Petroleum Holding Limited”; and
 - (iii) Column 4, by inserting —
 - (A) *Kumul Minerals Holdings Limited Authorisation Act 2015*.
 - (B) *Kumul Petroleum Holdings Limited Authorisation Act 2015*.
- (e) in Schedule 30 (Minister for Autonomous Regions) —
 - (i) the heading is deleted and substituted with “State Minister Assisting the Prime Minister on constitutional matters”; and
 - (ii) Column 2, by deleting “Minister for Autonomous Regions” and substituting it with “State Minister Assisting the Prime Minister on constitutional matters”; and
 - (iii) Column 3, by deleting all matters in Column 3 and inserting “All constitutional matters referred by the Prime Minister.” and
 - (iv) Column 4, by deleting all legislation in Column 4 and inserting “All Constitutional Laws referred by the Prime Minister.”; and
- (f) in Schedule 32 (Minister for National Planning), Column 3, by deleting “Office of Urbanization”.
