#### NOTICE OF EXEMPTION

Hidden Valley Services Limited wishes to engage the services of twenty-three (23) experienced non-citizens who are required urgently on-site for the Mill Shutdown. The Mill Shutdown is part of the Company's bi-annual plant refurbishment program in which the whole aim is to increase efficiency and increase gold production.

The exemptions granted in accordance to Section 51 of the *Employment of Non-Citizens Act* 2007 are always in the interest of the nation and for a good cause, in view of the Project's contribution to the country's development in terms of economic, human resource and infrastructure development.

The exemptions are granted from 30th December, 2015 to 30th November, 2016:

### Specific conditions placed against the exemptions are:-

- (1) For the Company to pay a fee of K1, 000.00 for each employee to the Department of Labour & Industrial Relations (a total of K23, 000.00);
- (2) For the Company to register all non-citizen employees that require registration with a professional body;
- (3) For the company to provide employment apportunities (decent, work, fair pay, promotion etc.) to citizen workers;
- (4) For the company to provide opportunities for human resource development and skills training to its employees;
- (5) Non English speaking countries to show evidence of English proficiency for applicants;
- (6) To have this *Gazettal Notice* revoked upon completion of this assignment by providing proof of repatriation for each non-citizen covered by this notice.
